1. WELCOME REMARKS

Commissioner Keefe called the special meeting to order and welcomed everyone. The purpose of this meeting is to conduct a community meeting to provide a presentation on the American Rescue Plan and to gather public input. Commissioner Keefe provided opening remarks about the ARP and introduced members of the ARP Committee. Commissioner Keefe recognized Town of Hope Mills Mayor Jackie Warner. Mayor Warner introduced Commissioner Jessie Bellflower and Town of Hope Mills staff in attendance. Mayor Warner stated the Town of Hope Mills received an ARP allocation of \$5.46M and if the funds are leveraged with the county and other sources, the Town of Hope Mills can do more with its share.

2. PRESENTATION BY COUNTY MANAGER AMY CANNON

Amy Cannon, County Manager, recognized county staff in attendance and stated the ARP Committee wants to get feedback from citizens as it relates to the use of Cumberland County's allocation of ARP funds. Ms. Cannon provided the following PowerPoint presentation about the ARP beginning with the agenda, photos of ARP Committee members and photos of the meeting facilitators.

American Rescue Plan Act

- President signed act on March 11, 2021
- Includes **\$350 billion** for state, local, territorial and Tribal governments (Coronavirus State and Local Fiscal Recovery Funds)
- Cumberland County's allocation is **\$65 million**
- Funds delivered in two payments; first in 2021 and second in 2022

U.S. Treasury Guidance (Interim Final Rule)

- Funds can cover eligible expenses from March 3, 2021 - Dec. 31, 2024

- Funds must be expended by Dec. 31, 2026
- Reporting requirements include expenditures and performance measures
- Administrative costs allowable
- Must provide evidence of specific harm caused by COVID 19 and how projects will demonstrate meaningful impact
- Recipients with populations over 250,000 must submit annual spending plan to Treasury by Aug 31, 2021

#### Eligible Uses of Funds

##### **A. Support public health response**

- **Prevent and mitigate COVID-19.** Potential uses include vaccination programs, testing, contact tracing and many related activities
- **Enhance behavioral health services,** such as mental health treatment, substance misuse treatment, hotlines, crisis intervention, overdose prevention and related services
- **Improve the design and execution of health and public health programs** to address the COVID-19 emergency through planning and analysis, which may include improvements to technology infrastructure and targeted consumer outreach
- **Address disparities in public health outcomes**

##### **B. Address negative economic impacts caused by the public health emergency**

- **Assistance to households or populations,** preferably those most disproportionately impacted (food, rent, mortgage, utility, home repairs, job training, etc.)
- **Small business and non-profit support** with loans, grants, in-kind assistance and technical support
- **Aid to impacted industries,** including the tourism, travel, hospitality and other impacted sectors

##### **C. Provide premium pay for essential workers**

- Offer additional support to those who have and will bear the greatest health risks because of their service in critical infrastructure sectors

##### **D. Investment in water and sewer infrastructure**

- Guidance allows for a broad range of necessary projects to improve access to clean drinking water and improve sewer infrastructure systems.
- Eligible uses are aligned to Environmental Protection Agency's (EPA) project categories for the Clean Water State Revolving Fund and Drinking Water State Revolving Fund.

##### **E. Investment in broadband infrastructure**

- **Focus on households and businesses** without access to broadband connectivity
- **Fund projects that deliver reliable service** with acceptable upload speeds

##### **Replace public sector revenue loss**

- Counties may use Recovery Funds for the provision of "government services" to the extent of the reduction in revenue experienced **due to the COVID-19 public health emergency.**

##### **Equity-Focused Services**

- **Additional flexibility for the hardest-hit communities and families** to address health disparities, invest in housing, address educational disparities and promote healthy

- environments for children
- Broadly applicable to **Qualified Census Tracts** and other disproportionately impacted areas


3. SURVEY SESSION

Please **rank** the funding categories in priority order of importance. Select the appropriate letter in the order you like, first keyed most important, last keyed least important.








- A. Services to address homelessness

Attendees were given note paper on which to write their responses. The responses were read aloud.


1. Make sure local fire departments have the funds, services, supplies they need

6. Homeless prevention program that includes building a community opportunity center
7. Critical infrastructure needs, clean water, sewer, broadband
8. What you are not considering is what area can you spend funds that have a chance to be recouped; \$65M becomes \$130M
9. Sue Dupont/Chemours
10. Consider regional initiative/partnering with other ARP recipients
11. Drug enforcement unit for Hope Mills Police Department; funds for more police



If you live in the City of Fayetteville, please select your Zip Code



If you live in other areas of Cumberland County, please select your Zip Code



- D. Severely



Do you have access to affordable high-speed broadband at home?



What is your relationship to Cumberland County?


- A. Live in Cumberland County



Are you connected in some way to the military?



Are you a veteran or spouse of a veteran?





How old are you?



Most people think of themselves as belonging to a particular ethnic or racial group. How do you identify yourself?


