1. CALL TO ORDER

Commissioner Keefe called the special meeting to order. The purpose of this meeting is to discuss the citizen engagement process, the community survey and community meetings.

2. APPROVAL OF AGENDA

MOTION: Commissioner Adams moved to approve the agenda.

3. APPROVAL OF MEETING SCHEDULE

Amy Cannon introduced Al Florez, Applications Manager, Innovation and Technology Services, and stated he was instrumental in assisting with the survey. Ms. Cannon also stated staff heard the committee at its June 16 meeting as it related to the community meeting schedule and reviewed the new schedule of five citizen input meetings below. Commissioner Adams asked that the City of Fayetteville also be part of the virtual meeting. Ms. Shutt stated the virtual July 29 meeting would be held on conference room 564 using GTM and citizens will respond via the chat function. Commissioner Adams stated ARP committee members could be in their offices and the city and staff could be around the conference table in room 564. Ms. Cannon stated Chairman Evans also asked that the committee hold a community meeting in Cedar Creek. Discussion followed about the number of meetings, the location of the meetings and the lack of capacity to live stream all the community meetings. Ms. Cannon stated the meetings can be recorded and made available on the county's website.

Ms. Cannon reviewed the additional meetings and deadlines below. Commissioner Adams stated he disagrees that there has to be an Annual Recovery Plan developed as quickly as August 16 and also that it is not required as part of the August 31 interim report; however, the committee could bring forth some priorities for the full Board to discuss. Ms. Cannon stated the schedule below is meant to be a general road map; the common theme in an earlier NCACC meeting was not to rush but begin getting feedback and putting thoughts together in order to leverage state money with ARP money once the General Assembly completes its deliberations. There was consensus to remove approval of the Annual Recovery Plan on August 16 and approve the meeting schedule with the City of Fayetteville added as part of the virtual meeting.

Discussion followed about a community meeting in Cedar Creek. Commissioner Adams stated the Cedar Creek community is trying to put together a meeting about water so an in-person ARP public input meeting can be held in conjunction with that meeting. Consensus followed.

4. APPROVAL OF AGENDAS FOR UPCOMING MUNICIPALITY AND CITIZEN INPUT MEETINGS

Ms. Cannon reviewed the agenda for the meeting with the Mayors' Coalition and stated she will provide a brief presentation on the ARP, Justin Hembree will provide a presentation on assistance being provided to small municipalities by the MC-COG, there will be a roundtable discussion with the Mayors about their use of ARP funds and whether they have thoughts about collaboration with the county. Ms. Cannon stated the thought was not to necessarily have the mayors weigh-in on how the county spends its money.

A brief discussion followed about what to include in the meeting with the mayors, the roundtable discussion, the presentation by Justin Hembree and the press release about the plan. Commissioner Adams asked that Mayor Turpin, Chair of the Mayors' Coalition, also be recognized and provide a welcome. Consensus followed.

Ms. Cannon reviewed the agenda for the citizen input meetings and stated she will provide a brief presentation on the ARP followed by the survey using the clickers. Commissioner Adams asked that mayors of the respective towns provide a welcome and stated citizens need to know what entities received ARP funds and the amounts received, and the possibility of receiving additional state dollars. In response to a question posed by Commissioner Stewart, Ms. Cannon stated at the meeting will be open for citizen conversation at the end of the survey session either in groups or individually.
