INFORMATIONAL/DISCUSSION ITEMS

A. Public Comment: Dr. Ojo opened the floor at 6:30pm for public comments. Being that there were no registered public comments, Dr. Ojo closed the floor at 6:31pm.

B. Financial Reports

Mrs. Candi York presented the financial reports for the month ending January 31, 2023.

The statement of revenues and expenditures for the month closing January 31, 2023, exceeded our expenditures of \$845,372.63.

Expenditures by programs expended 41.74% and 15.79% COVID reporting as of January 31, 2023.

We have earned 44.54% of revenue by source which is in line with our budget.

Accounts Receivable was broken down by payor source with an accounts receivable aging report available for private pay as of January 31, 2023.

Mr. Fiser asked if there would be any issues with COVID funds since 543 is out, will we have to pay for our own vaccines? Mrs. York said that at this time we were unsure but would relay the message as soon as a decision was made.

C. Dental Health Month Proclamation

Ms. Tamra Morris presented the Dental Health Month Proclamation in honor of Dental Health Month. Our health department was awarded 3000 from Delta Dental and will provide a sealant program in kindergarten through middle grade-schoolers.

D. Discussion of New Board of Health Members

The Board members were given a list of applicants who had applied for the vacant Board of Health position. Several had already sent in their resumes and were reviewed at this meeting. The Board asked that 3 candidates be invited to the March meeting to speak about 3-5 minutes about their interest in being on the Board of Health. Kelly will send the invite to the candidates.

E. External Reports

An Accreditation report was given out to all Board Members to review. Dr. Green added how well the Accreditation visit went on January 26th and thanked the Board members for coming out in a quorum, to speak to the site visitors. Our official results are not back, however Dr. Green explained that we met 146 out of 146 activities and were being recommended for Full Accreditation with honors. This will take place in May in Raleigh. Dr. Green also handed out the Health Community Programs Site Visit Report and discussed how well the site visit went in January.

F. Director's Report

Dr. Green discussed the need for a resolution of Medicaid expansion. Health Departments have made progress, but waivers are ending in March. Every Medicaid recipient will be re-evaluated to see if they remain eligible. House Bill 76 is in the Senate's hands. The Health Care Freedom Act is a bill not requiring children to get vaccines. The Board agreed to proceed with a joint resolution with Department of Social Services.

Dr. Green spoke on the Opioid Settlement Funds where the Commissioners met yesterday to discuss the funds. There is an amendment to the current MOU. The MOU will be signed in March and will total 30 million over an 18 year period. April 18th is the deadline to sign. The state requires 2 reports, a financial report and program report.
