-237 opioid overdose ED visits in CC for 2023 YTD compared to 232 in January-November 2022.

-605 overdose ED visits for MED/Drugs with dependency potential in CC, 2023 \*YTD compared to 642 from January-November 2022

-601 Opioid overdose ED visits November 2023 compared to 748 November 2022.

-249 Fentanyl-Positive Deaths<sup>^</sup>, September 2023 compared to 292in September 2022.

-1,102 overdose ED visits for Med/Drugs with dependency potential in November 2023 compared to 1,337 in November. 2022.
