Introduction

The Cumberland County Department of Public Health (CCDPH) provides an array of services to the citizens of the county. The department's mission is to provide high-quality service in a professional, efficient, and fiscally responsible manner while improving the health of Cumberland County.

Federal, state and county tax dollars help fund the Health Department. Grants and fees for service generate additional funds. The Department of Public Health is governed by the Cumberland County Board of Health, composed of 9 members appointed by the County Board of Commissioners.

The CCDPH was founded in 1911 as the Cumberland County/Fayetteville City Board of Sanitation and Health, but it had no paid employees. In 1923, a part-time physician and two nurses were hired as the first paid employees.

Today, the department has a budget of more than \$22 million and 220 employees working from the Public Health Center located at 1235 Ramsey Street and three satellite offices. A variety of professionals are employed including physicians, public health nurses, finance staff, communicable disease control specialists, community health assistants, computer personnel, environmental health specialists, public health educators, housekeepers, licensed practical nurses, medical lab personnel, management support staff, nutritionists, pharmacists, physician extenders, social workers and administrative staff.

In North Carolina, local health departments are governed by local boards of health who are responsible for public health within its jurisdiction. The 11 member Cumberland County Board of Health includes representation from the county commissioners, professionals with expertise in health care or public health, and members of the public. The Cumberland County Board of Health also serves as the policy-making, rule-making, and adjudicatory body, for the public health department.

Board of Health meetings are held at the third Tuesday of each month at 6 p.m. at the Health Department (1235 Ramsey Street). Meetings are open to the public. Previous Board of Health meeting agendas and minutes are available on the Cumberland County <u>website</u>.

Twenty-one months prior to my arrival, the Board of County Commissioners determined the organizational structure that would most effectively serve the public was to have the Cumberland County Assistant County Manager, Duane Holder lead the Health Department. It was immediately evident to me the Health Department team remained invested in the agency's vision to

have healthy people living in a healthy community during this interim period. Our team of more than 200 knowledgeable and skilled staff continued to carry out the agency's mission to provide high quality services in a professional, efficient, and fiscally responsible manner while improving the health of the community.

Annually, the health department publishes a report that highlights some of the agency's accomplishments and outcomes. This annual report includes a summary of our efforts for calendar years 2018 and 2019. Whether it is in our clinics, three WIC (Women, Infants, and Children) locations, two environmental health locations, during our home visiting program, or through our health education and health promotion programs, the agency continues to provide programs and services for community members throughout their lifespan. The department has a budget of more than \$22 million and 220 employees working from the Public Health Center to meet the needs and improve the health of the whole community.

Accreditations, Awards & Recognition



Accreditation is achieved by meeting requirements with evidence by completion of activities through the Health Department Self-Assessment Instrument (HDSAI) and Site Visit.

The North Carolina Local Health Department (NCLHD) Accreditation Program links basic standards to current state statutes, administrative code and contractual and program monitoring requirements that are already in place through the Division of Public Health. This process allows local health departments to assess how they are meeting national and state-specific standards for public health practice and provides the opportunity to address any identified gaps.

Cumberland County Department of Public Health is an accredited public health department and was re-accredited 2017-2021.

Grant Awards

In 2018 and 2019 the CCDPH was successful in its pursuit of grant funding. The department was awarded **\$1,215,500** in grants. The awards include the following:



FY18 Grants

Awarded to CCDPH from the Association of Food and Drug Officials (AFDO), these three grants provide support training and travel costs for Environmental Health staff. They totaled **\$17,000**.



FY19 Grants

Environmental Health - Healthy Homes **\$8,000** to address asthma triggers in homes.

Positive Parenting Program (Triple P) **\$290,500** to address child abuse and neglect, out of home placement and foster care. This project aims to build parents and caregivers confidence with positive parenting tips from birth to teenage years. CCDPH is the lead implementation agency and will serve 18 county area to include Cumberland, Hoke, Harnett, Lee, Moore, Montgomery, Scotland, Anson, Richmond, Sampson, Robeson, Bladen, Duplin, Onslow, Pender, New Hanover, Brunswick, and Columbus Counties utilizing funding from the NC DPH Children and Youth Branch.

Cumberland - Fayetteville Opioid Response Team

The CCDPH has been awarded a three-year grant from the U.S. Department of Justice totaling approximately **\$900,000** for a Comprehensive Opioid Abuse Sitebased Program.

The Cumberland County Board of Commissioners accepted the grant award today during their regular meeting and approved a budget ordinance to recognize the funding. The award for fiscal year 2020 is **\$289,131.**

The grant allows for the following:

- A full-time project coordinator position at the Health Department
- Implementation of a Post-Overdose Response Team (PORT)
- Enhanced Pre-Arrest Diversion Programming
- Community Education Campaign
- Establishment of an Overdose Fatality Review Team

The N.C. Injury and Violence Prevention Branch of the N.C. Department of Health and Human Services Division of Public Health has collected opiate poisoning death data since 1999. Data collected for Cumberland County early on reflected an average of eight to 14 deaths annually related to opioids. Cape Fear Valley Medical Center was ranked in the top five throughout the state for opioid-related overdose emergency department visits.

Environmental Health Division

The Environmental Health Division prevents environmental contamination and promotes public health safety for the citizens and visitors of Cumberland County through inspections, education and enforcement of state and local rules/regulations.

Environmental and sanitation inspections were completed for restaurants, daycares, hotels, institutions, tattoo parlors and other establishments. Environmental Health also issued permits, provided consultative visits, completed soil evaluations, collected water samples and investigated complaints.

Temporary Food Establishments

Environmental Health staff inspected and permitted temporary food establishments (TFEs) for more than 82 events held in the county in 2018 and 2019. Some of the more popular events included the Cumberland County Fair, the Dogwood Festival, the International Folk Festival, and Fayetteville State University's Homecoming. Environmental Health Specialists permitted more than 11 individual food vendors at some of these events to ensure the public is protected against foodborne illnesses.

Mosquito Control

In an effort to combat the mosquito population, Environmental Health's Mosquito Prevention Program provided two month supplies of mosquito dunks free to Cumberland County residents in 2018 and 2019.

Women's Preventive Health Services

Women's Preventive Health Services includes Family Planning and Maternity Clinics, as well as the Breast and Cervical Cancer Control Program (BCCCP) and WISEWOMAN programs.

Family Planning Clinic

The Family Planning Clinic serves women of child-bearing age desiring to plan and space births by providing contraceptives and preconception counseling. One of the goals of the clinic is to reduce infant mortality and morbidity by decreasing unintended pregnancies. The clinic offers many forms of birth control to accomplish this goal, including long-acting reversible contraceptives (LARC) such as Mirena and Paragard Intrauterine devices, and the subdermal implant Nexplanon.

Breast and Cervical Cancer Control Program/WISEWOMAN

The North Carolina Breast and Cervical Cancer Control Program (NC BCCCP) provides free or low-cost breast and cervical cancer screenings and follow up to eligible women in North Carolina. Breast and Cervical Cancer Medicaid (BCCM) provides funding for cancer treatment to NC BCCCP-enrolled patients who are diagnosed with breast or cervical cancer and meet additional requirements. A woman must be enrolled in the Breast and Cervical Cancer Control Program prior to a cancer diagnosis to be eligible for Breast and Cervical Cancer Medicaid.

The Well-Integrated Screening and Evaluation for Women Across the Nation (WISEWOMAN) project provides cardiovascular disease screening, intervention, counseling, and referral services to BCCCP enrolled women. WISEWOMAN provides low-income, underinsured, or uninsured 40- to 64-year-old women with the knowledge, skills, and opportunities to improve their diet, physical activity, and other life habits to prevent, delay, or control cardiovascular and other chronic diseases. The NC WISEWOMAN project began provides services for eligible women in the BCCCP clinic.

Maternity Clinic

The Maternity Clinic strives to reduce the maternal and infant mortality and morbidity by providing access to early and continuous prenatal care. The Department of Public Health contracts with Cape Fear Valley OB/GYN for ongoing prenatal care with delivery services.

The clinic offers prenatal patients a unique service, in-house ultrasounds conducted by a private physician. Comprehensive prenatal and postpartum education is provided throughout the patient's pregnancy. Other services offered include a registered dietitian who conducts nutritional assessments and assists patients with setting and meeting nutritional goals, nurses who conduct several screenings during pregnancy to monitor and assist the patient with a healthy lifestyle for a happy healthy outcome. Some of these screenings include lead, TB, risk assessment screenings, depression, smoking cessation, screenings for psychosocial needs and assess for obstacles from keeping prenatal appointments.

Care Management Program Services

Pregnancy Care Management

Pregnant and postpartum women receive supportive health, medical and educational services to improve and promote healthier pregnancies and births. Pregnancy Medical Homes (PMH) continue to work with Pregnancy Care Managers by screening and referring patients with high-risk conditions. Care Management encourages early and continuous prenatal care, postpartum follow up care, positive mental and physical health and continuation of primary medical care for health promotion and disease prevention.

At the end of 2019, the names of programs for pregnant women and at-risk children changed under managed care. The new names are to distinguish the Fee-for-Service programs from the managed care programs. The new names are Care Management for At-Risk Children (CMARC) and Care Management for High-Risk Pregnant Women (CMHRP).

Care Coordination for Children

The population of infants and children who have been admitted to neonatal intensive care units (NICU), have chronic medical conditions, live in a toxic and stressful environment, or receive foster care services through the Department of Social Services (DSS) has fluctuated over the year. Care Management focuses on connecting patients with a primary medical home, home health medical services, resolving toxic stress conditions, assist DSS social workers with continuity of care for children in foster care, developmental therapy and/or therapy and receipt of local and out-of-county medical specialists to ensure they receive necessary care.

Newborn/Postpartum Home Visiting Program

This program is a key mechanism for reaching families early with preventive and anticipatory services (a proactive approach to customer service Instead of waiting for problems to happen, it means you can avoid a problem happening in the first place). The nurse provides timely referrals for any needed services and serves as a link to children's preventative services. Home visits take place within the first 60 days of delivery and any pregnant woman in Cumberland County is eligible for services. The face-to-face visit takes place in the patient's home and includes assessment counseling, teaching, and if needed, referrals to other providers for additional services for both mom and baby.

Women, Infants, and Children Nutrition Program

The Women, Infants, and Children (WIC) Program is a supplemental food and nutrition program that has been operating in Cumberland County since 1978. The Cumberland County WIC Program is the third largest WIC program in the state. Services are provided daily at the Public Health Center and two full-service satellite clinics; one in Hope Mills and one in Spring Lake. The program offers extended hours to 7 p.m. on the 2nd and 4th Tuesday of the month at the main site. The clinics operate during lunch hours and walk-ins are welcome. We started offering WIC services at the DSS in November from 9 a.m. to 4 p.m. Monday, Wednesday, and Thursday.

Online low risk nutrition education is available for participants to complete lessons and qualify for remote benefits issuance.

The program's goal is to promote healthly lifestyle behaviors by providing current, sound nutrition guidance to all eligible individuals. These include pregnant, postpartum and breastfeeding women, as well as infants and children up to age 5. They do this by offering a combination of nutrition education, breastfeeding education/support and supplemental foods. Food packages include fruits, vegetables, whole grain cereal and bread, eggs, peanut butter or beans, 1% low-fat milk, yogurt and cheese.

The program strives to provide a warm and friendly environment for WIC Program clients. There is a lactation room where mothers can have a comfortable setting to breastfeed infants in private, if desired, while attending clinic appointments.

The SFY 2018-2019 assigned monthly client base caseload was 12,004. Participation for the months closed for SFY 2018-2019 (July-Oct 2018) was 12,309 or 102.5% of assigned base caseload. This exceeds the 97% requirement participation rate of assigned base caseload. These numbers represent higher than normal participation due to Nutrition Services Branch (NSB) electronically issuance of food benefits to participants who may not have been able to come to the WIC Program due to the hurricane in September of that year.

The assigned caseload for 2018-2019 was 12,773 and are serving less than the required 97% of the base caseload assignment. Low participation was a trend throughout the state. WIC participation continued to decline across the country.

The WIC program continued to participate in health department and community and Fort Bragg events to provide information on WIC services, attract applicants, and maintain current participants. There have been several media campaigns locally and state-wide to bring more attention to the availability of WIC services in the area. Ongoing radio announcement being aired on local radio stations in this area.

Teen Wellness Clinic

The Teen Wellness Clinic is responsible for providing high-quality teen-friendly health care to youth ages 12-19 years old. The clinic provides family planning services as well as testing and treatment for sexually transmitted infections.

Services Provided

- Immunizations and other shots for school or college (some require parent's signature)
- Birth control
- Pregnancy testing
- STD testing and treatment
- Teen Advocate- caring professional who works one-on-one with youth to answer questions about health and birth control options
- Well care -physical and sports physicals (requires parent's signature)
- Sick care (requires parent's signature)
- Care for chronic conditions-asthma, obesity, and others (requires parent's signature)

Female patients ages 14-19 are also invited to participate in an evidence-based intervention "17 Days", an interactive film aimed at reducing the negative outcomes of risky sexual behavior. The DVD is designed to help adolescent females make positive decisions. Young women can learn how to make their relationships works for them and reduce the risk of unplanned pregnancy and sexually transmitted infections. The video includes content addressing four key topics: vignettes, condom demonstrations, gynecological exams, and disease information.

Clients seen in the Teen Wellness Clinic can pay with insurance or Medicaid. If clients are unable to pay, they can qualify for free or low-cost care. By law, clients are covered by Minor's Rights to Access Care and services are confidential.

Adult Health Primary Care Clinic

The Adult Health Primary Care Clinic provides primary medical care for patients that have acute and chronic diseases. A sliding fee scale service is available to patients who financially qualify and CCDPH is contracted with Medicaid, Medicare, and Blue Cross Blue Shield. For patients that did not meet the sliding scale qualifications or have insurance with a company listed above, a \$10 fee per visit per client was charged.

During 2018-2019, the Adult Health Primary Care Clinic continued its partnership with HealthNET and Stedman-Wade Health Services. Stedman-Wade provides comprehensive medical care for Cumberland County residents. The 8-year relationship with HealthNET continued and HealthNET specializes in seeing patients with a diagnosis in: diabetes, hypertension, congestive heart disease, and asthma.

Immunizations Clinic

The Immunizations Clinic is staffed by registered nurses and administrative support. The clinic is a walkin clinic and serves the general public by administering both required and recommended vaccinations to children and adults. It is a regional immunizations clinic, as many of the vaccines needed by overseas travelers are offered, such as typhoid.

Child Health Clinic

The Child Health Clinic provides medical screenings for children from birth to 18 years of age. Services include primary care (including sick children); physical examinations that include a developmental screening; dental, hearing and vision screenings; preventive education; scheduled vaccinations; nutrition and laboratory screening.

The Child Health Clinic has one enhanced role nurse who performs well-child physicals to enhance services offered to the children of Cumberland County. The Child Health Clinic is a Carolina Access provider. Fees for services are based on family size and income.

Communicable Disease Control

Epidemiology Clinic

The Epidemiology Clinic monitors, surveys, investigates, and reports communicable diseases (including, but not limited to, foodborne and vectorborne diseases) and provides treatment under circumstances that require public health action in order to prevent or diminish the magnitude of an outbreak. The North Carolina Electronic Disease Surveillance System (NCEDSS) is the statewide database used by the Epidemiology Clinic to access information and report cases.

One component of the Epidemiology Clinic is the local Tuberculosis (TB) Control Program. The Department of Public Health follows strict NC TB Control Guidelines to serve Cumberland County residents who are diagnosed with active TB disease and latent TB Infection.

The Epidemiology Clinic also receives reports of acute and chronic Hepatitis B that requires followup. A secondary component of the Hepatitis B Program is Perinatal Hepatitis B, which requires case management and assurance of follow-up care by the primary care provider of both the infected mother and her infant.

The Epidemiology Clinic is also responsible for the Rabies Program, which includes maintenance of a dog of bite reports received from Cumberland County Animal Control. Animal bites/scratches/exposures that carry a risk of rabies are investigated to provide rabies education and advice to those that may need rabies prophylaxis.

The Epidemiology Clinic is responsible for locating refugees and immigrants (that meet certain criteria) who settle in Cumberland County to assure screening for communicable diseases and follow-up.

Sexually Transmitted Disease Clinic

The Sexually Transmitted Disease (STD) Clinic provides screenings, diagnosis, treatment and counseling for chlamydia, gonorrhea, syphilis, trichomoniasis, candidiasis, genital warts, genital herpes, bacterial vaginosis and HIV. The purpose of the STD program is to reduce the incidence of STDs in Cumberland County by providing preventive and therapeutic treatment for all reported cases and contacts. Our Communicable Disease Control Specialists (CDCS) increase awareness of high-risk behaviors by utilizing education and community outreach to inform Cumberland County residents.

Health Education

The Health Education Division provides innovative educational programs that promote the physical, emotional, and social well-being of individuals and communities. Health Education is responsible for planning, organizing, and implementing programs for clinic patients, community groups, civic organizations, private agencies, worksites, and schools. The Health Education Department addresses the following program areas: Communicable Disease, Maternal and Child Health, Health Promotion, Women's Preventive Health, and general health education.

Community Health Assessment 2018

Led Cumberland County's efforts to participate in the Eastern Regional Community Health Needs Assessment (CHNA) with community partners to organize as a community, data collect, train and hosts focus groups throughout the county.

- This led to the collection of 1,265 community health assessments and six (6) focus groups implemented county-wide.
- Identified the following five (5) priorities with the 30 community partners and community stakeholders:
 - 1. Access to Health Services
 - 2. Economy
 - 3. Exercise, Nutrition & Weight
 - 4. Public Safety
 - 5. Substance Misuse

Tobacco Control

In the spring of 2015, Cumberland County received funding from the Tobacco Prevention and Control Branch of the North Carolina Department of Public Health to fund a Regional Tobacco Control Manager position for Region 6, which covers 10 South Central NC counties: Cumberland, Hoke, Harnett, Lee, Moore, Montgomery, Randolph, Richmond, Anson, and Scotland Counties. The Regional Tobacco Control Manager provides expert leadership and guidance on evidence-based tobacco prevention and control strategies that reduce secondhand smoke exposure, prevent the initiation of tobacco use, and promote cessation services for those who wish to quit.

Over the five-year grant period, the Regional Tobacco Control Manager will be involved in the following activities:



School Health

The school health program is staffed by a team of public health registered nurses who provided screening, education, counseling, and other health services to over 50,000 children in the Cumberland County School System.

Pharmacy

In 2018, CCMAP has assisted its patients with securing 27,323 prescriptions with a value of \$10.4 million(AWP), and the program averaged 474 new prescription requests each month that were submitted to the manufacturer indigent programs. Since the program began through 2018, CCMAP has dispensed 353,482 prescriptions with a value of \$ 111.6 million (AWP).

Since opening 2019, CCMAP has dispensed 381,665 prescriptions with a value of \$ 118.8 million (AWP), for the indigent, enabling them to better manage their chronic disease such as diabetes and heart disease, and maintain a high quality of life. By having access to maintenance medications, participants are able to control chronic conditions and improve their health status, resulting in decreased emergency room visits and hospitalizations. CCMAP assists patients with securing the medications they need through the indigent programs offered through the pharmaceutical companies, through dispensing samples that have been donated by area physicians, as well as through purchasing and dispensing generic medicines that are not available through any indigent programs.

The Pharmacy, located on the first floor of the Public Health Center, is also a medication access program called CCMAP. The Cumberland County Medication Access Program (CCMAP) is dedicated to improving the quality of life for eligible residents of Cumberland, Hoke, Harnett and Sampson counties by operating a licensed, non-profit pharmacy that assists patients with obtaining medication for chronic disease. The medication access program began in 2002 when the Cape Fear Valley Board of Trustees hired its first program manager for CCMAP. The staff collaborated with Better Health of Cumberland County, the CARE Clinic, the mental health center, DSS and CCDPH to jumpstart the program.

Preparedness

The Office of Preparedness & Response (PHP&R) develops and exercises Preparedness & Response Plans for the agency to use in the event of natural or manmade disasters.

The Office of Preparedness & Response is also responsible for preparedness training, including: Respiratory Protection Training (209 Staff), Medical Countermeasure (208 staff), Shelter Training (75 staff), and Personal Protective Equipment (PPE) (204 staff). Active Shooter Training (208 staff), Emergency Action Plan/Fire Safety/HAZCOM Training (209 staff), and Opioid and Methamphetamine Awareness Training (78 staff).

The Office of Preparedness & Response is developing a partnership with Ft. Bragg and the Veterans Affairs Hospital for Medical Countermeasure dispensing.

Medical Laboratory

The CCDPH Laboratory is a full-service Clinical Laboratory Improvement Amendment (CLIA) certified laboratory with two certificates. The lab has a Certificate of Compliance to perform Moderate Complexity Testing and a Certificate of Waiver to perform waived testing.

The lab is currently enrolled in a proficiency program with the American Proficiency Institute in which all staff participates quarterly to verify competency. The CCDPH lab is inspected every two years by CLIA and has passed its fifth consecutive inspection with no deficiencies or citations.

In 2018 we tested and processed 39,807 labs in-house and filled 29,452 prescriptions. During 2019 we tested and processed 28,498 labs in-house and added one test to partner with DSS. We perform drug screen testing for Child Protective Services. We have a staff of four techs, one lab assistant and two contract phlebotomists. Staff passed another inspection with no deficiencies or citations in April of 2019 and we are certified as a Moderate Complexity Lab until April 2021 and Waived Lab until July 2021.

Medical/Vital Records

The Medical Records Division is responsible for the retention of all patient records. The CCDPH began the transition to electronic health records in April 2014. The Medical Records Division staff ensure all active patient records are scanned in a document management system that allows the record to be viewable prior to and during an appointment.

The department supervisor serves as the Health Information Portability and Accountability Act (HIPAA) Officer. The officer ensures all public health employees receive initial and updated trainings, as well as maintains up-to-date information for policies and the Notice of Privacy Practice. All members of the CCDPH staff, providers, temporary staff and interns receive HIPAA, Confidentiality and Privacy Act training.


