# CUMBERLAND COUNTY PUBLIC LIBRARY MINUTES LIBRARY BOARD OF TRUSTEES – SPECIAL MEETING JULY 25, 2022 (1:30p.m.)

# I. CALL TO ORDER

Before the final vote, Trustee Fiser asked if the proposed revised policy would not limit room access to customers. Interim Deputy Director Hall said that the previous policy was essentially the ALA Bill of Rights and the Library's internal procedures need to match the County's policies and will with the proposed changes. Fiser agreed and wanted to make sure that the new policy would not create barriers when the goal is to build access.
