5.1 INSTALLATION OF SYNTHETIC TURF ON HIGH SCHOOL FOOTBALL FIELDS AND TRACKS

Council Member Arp presented this item and provided a handout. Council Member Arp stated Cumberland County, Cumberland County Schools, and the City of Fayetteville should collectively investigate the benefits of installing synthetic turf on high school football fields and tracks. Converting natural grass field to synthetic turf fields provides a solution to the increased countywide demand for use of outdoor fields and to improving the quality of both our school and parks and recreation facilities.

Council Member Arp recommended the Liaison Committee establish a Joint Task Force with the intent of returning to this committee with findings on best practices, cost and financing for the conversion of grass fields at the high schools.

Discussion ensued. Chair Council asked Council Member Arp if the school district is willing to work together on this project. Council Member Arp stated he had been in conversations with school administration, and there is an interest.

a committee to investigate this item and report back to

5.2 BRAC COMMITMENTS

Chair Council introduced this item and stated she had received a communication from an area hotel requesting assistance with creating dialogue with Fort Bragg officials to encourage use of the Embassy Suites for conferences, off-site meetings, and other events.

Consensus of the Committee was to engage in dialogue with Fort Bragg officials when the occasion presented itself.

6.0 OTHER ITEMS OF BUSINESS

Chair Council questioned if the frequency of meetings in 2015 was to remain at every other month.

Consensus of the Committee was to hold the meetings every other month in 2015; meetings to be held at the Hilltop House restaurant.

Commissioner Keefe requested an update on the potential consolidation of the 911 centers. Ms. Amy Cannon, County Manager

stated she had met with Mr. Voorhees, City Manager and discussions had taken place.

Consensus of the Committee was to request a written report to the Committee on the potential co-location of the 911 centers; to be presented in the next quarter.

Mr. Michael Gibson, Parks, Recreation, and Maintenance Director provided a handout to the Committee on the Fayetteville-Cumberland Youth Council update.
