The meeting was duly called to order.

## AGENDA ITEMS:

1. Approval of the May 16, 1996 Meeting Minutes.

2. Discussion of Bond Anticipation Notes for the Library Project.

Deputy County Manager James Martin reviewed the copy of the letter from the County Manager to the Local Government Commission concerning Bond Anticipation Notes for the library project. He reviewed the projected costs for the BANs. This item will appeal on the August 19th Commissioners meeting agenda for approval by the full board. He noted management anticipates the BANs to be sold on September 10th.

board of Commissioners.

3. Courthouse Fourth Floor Renovation Project Financing.

James Martin advised the County is bank qualified for financing for the Fourth Floor Renovation Project. Bank financing will have a better interest rate. The Architect working on the renovation project has prepared a pre-final draft of the drawings. Management would like to bid this work out by the end of this month. Once the bids are in, contact can be made with local banks for financing. Management would like to coordinate the financing for the fourth floor project with the purchase of the new Sheriff's Office cars and the costs to upgrade the county's mainframe computer system. The exact cost of the fourth floor project will be the only cost that will be hard to determine.

Commissioner Faircloth stated he is concerned that the costs to do the fourth floor renovation project will be unusually high because the court system has indicated they will want the work to be done at nights and on weekends so that it will not disturb court during the day.

Mr. Martin noted all of the contracts will be brought before the full Board for approval.

Neil Yarborough stated he has had dialogue with the Chief Resident Court Judge about this matter. He feels some type of contingency can be worked out.

It was the consensus of the committee to advise management to take any other matters concerning this project to the full Board for consideration and approval, in order to expedite the process.

4. Cash Investments Report.

Carlisle McCutcheon reviewed the Investment Portfolio for the fourth quarter. He noted the County did well on it's investments due to higher interest rates. He keeps as much as possible invested at all times.

5. Employee Discounts on Health Insurance Premiums.

Mr. McCutcheon reviewed the memorandum dated August 17th concerning employee discounts on health insurance premiums. He noted the purpose of the discount is to give employees an incentive to be in the Wellness Program or to stop smoking. He reviewed the potential additional costs if retirees are included in the Wellness program. He will pursue this matter further with committee approval.

MOTION:

Commissioner Warren offered a motion to recommend approval of offering County employees discounts on health insurance premiums and directed the Finance Director to prepare the necessary information for presentation to the full board.

DISCUSSION: Commissioner King noted this is a good idea. He wonders if there will be additional discussion concerning the non-smoking piece.

Commissioner Warren noted private insurance companies offer discounts for non-smokers. Mr. McCutcheon advised some employees have informed him a discount on their insurance premiums would be the incentive they needed to stop smoking.

Commissioner King asked why some employees are not participating in the Wellness Program.

Mr. McCutcheon advised employees in his office that do not participate have indicated they do not want to take the time, even though they do not have to use their leave in order to participate.

Mr. McCutcheon presented information on a group life insurance program for County employees. He reviewed the handout for the committee. He noted he is working on an agreement with the company to place a three year hold on the premiums. The county could purchase this coverage out of the insurance fund with no additional costs. He noted the school system as well as the State offers this insurance to their employees.

Commissioner Warren asked if employees would be able to keep the insurance after they left the County.

Mr. McCutcheon advised the company won't agree to that condition at this time, and will not include it in their contract.

It was the consensus of the committee to allow the Finance Director to pursue this benefit for county employees with the appropriate insurance company.

Mr. McCutcheon also noted he will pursue a cap on the premiums as well.
