2. Health Insurance for Board of Education Members

BACKGROUND: On September 15, 2003, the Board of Commissioners approved a request from the Board of Education to allow members of the Board of Education to participate in the County health insurance program. On October 13, 2003, the County Manager received a letter from the Chairman of the Cumberland County School Board requesting reconsideration of the matter, specifically to provide the same health insurance as that available to the Cumberland County Board of Commissioners.

The County Manager explained that, if approved, the school board would pay the premium amount only and not share in the potential losses. The coverage would also include dependents of school board members. The school board members would pay the additional premiums for dependents.

The County Attorney noted that the statutes say the Board of Commissioners shall set the rate of compensation for Board of Education members.

The County Manager asked for a revision in the wording of the Resolution. Instead of "satisfactory to the County Manager," the Resolution would state "satisfactory to the County Attorney."
