A. Minimum Housing Hearing (deferred by Board of Commissioners from their October 18, 1999 meeting). MH679-99 - Thomas J. Roberts, 4766 South Main Street, Hope Mills - PIN 0413-86-9608.

Affidavit of the Housing Inspector's Report:

I, Kim Reeves, Inspector for the County of Cumberland Inspection Department, acting in my official capacity, being duly sworn, depose and say:

BACKGROUND: That the following is a report on case number MH679-99

Property Owner: Thomas J. Roberts Property Address: 4766 South Main Street, Hope Mills, NC (1973 Skyline 12x66 mobile home) VIN 0112494G

Tax Parcel ID Number: PIN 0413-86-9608

SYNOPSIS: This property was first inspected on April 22, 1999. This case was initially heard by This Board at the October 18, 1999, regular meeting. At that meeting, the Board adopted the orderOf the Housing Inspector as the true facts in this case and deferred action for six months until the April3, 2000 meeting to allow time for Mr. Roberts to bring the property up to Code. Upon myreinspection of the property on March 17, 2000, the septic tank has been installed; however, it isnot connected to the mobile home. Some siding has been installed to approximately one third of the exterior, and some sheet rock hung on interior walls and ceilings; however, none of the required permits have been obtained (Building, Electrical, Plumbing, Mechanical) and no inspections requested or conducted. None of the electrical wiring, plumbing or heating has been installed or repaired in the mobile home and no repairs have been made to the structural frame of the unit. The Tax Office has informed me that the mobile home was not listed for property taxes in 1999 or 2000.

Ms. Reeves indicated she could not gain access to the mobile home, noting she had tried to set up appointments to meet with Mr. Roberts, but he was out of town and cancelled the appointments.

Speakers:

1. Tom Roberts, owner. Mr. Roberts said he could not finish the project because the Minimum Housing Inspector would not let him, noting the Inspection Department requires him to provide a letter of structural integrity, which he says will cost him \$4,000. He said he was able to contact an architectural engineer who inspected the mobile home and said he could not find anything wrong. He blamed the County Inspection Department for keeping him from bringing the structure up to code. He said he did not think the people in the Inspection Department were qualified to do an inspection.

2. Clinton Harris - Mr. Harris asked the Board to give Mr. Roberts another year to fix the mobile home. He said it was secured and did not constitute a health or safety hazard.

Commissioner Blackwell noted that Mr. Roberts would not make the premises available for inspection a year ago when this case first came before the Board. He also noted that Mr. Roberts did not attend the hearing at the Inspection Department. Commissioner Blackwell said he thought the County has been fair with Mr. Roberts.

In response to a question from Commissioner Warren, the Inspection Department noted the State Building Code requires certification from a third party confirming the structural integrity of the building. Commissioner Warren inquired as to why Mr. Roberts did not secure permits or list his property for the last two years. Mr. Roberts said it was just a matter of time before he got the permits. He said he left it up to someone else to list his property and he did not know it had not been listed.

Commissioner King asked Mr. Roberts how much money he has spent on rehabilitating the mobile home. Mr. Roberts said he has spent about \$6,000. He said he could not afford to put another \$4,000 in the property.

Commissioner Baggett told Mr. Roberts it was his responsibility to get the permits to rehabilitate the mobile home. He noted that Mr. Roberts is in the construction business and he surely knows what is required. Commissioner Baggett noted that the County Inspection Department is doing their job and Mr. Roberts is not doing his.

Chairman Melvin asked Mr. Roberts if the Board were to give him more time, would he fix up the mobile home? He said he would but would not spend another \$4,000 for an engineer to certify structural integrity.

Commissioner Tyson said he would like to find a way to help Mr. Roberts out and inquired why the letter concerning the need for certification of structural integrity was not given to Mr. Roberts until March 17, 2000. Ms. Deborah Simpson of the County Inspection Department said Mr. Roberts would have received that information when he came in to secure permits to do the work; however he has not been in to get his permits.

In response to a question from the County Attorney, Ms. Simpson noted she was a North Carolina certified Plumbing/Mechanical Systems/Electrical Inspector and she also serves on the NC Building Code Officials Qualification Board.

Commissioner King said he felt there was a lack of enthusiasm on Mr. Roberts part to finish the project.

To order the property owner to remove or demolish the dwelling within

thirty (30) days; and

To order the Inspector to remove or demolish the dwelling, if the owner fails to do so and impose a lien on the real property for the cost of such action; and

To direct the Clerk to incorporate the foregoing findings and orders in an ordinance certified by the Chairman and record the same in the Register of Deeds.

SPEAKERS: Clinton Harris: Mr. Harris asserted that the issue of race influenced what roads would be paved.

Commissioner Warren noted that Bogie Island Road has been on the list and seems to get bumped each year. He asked if rights of way have been secured and what would happen if some people at the end of the road would not give a right of way. Mr. Stone noted that DOT likes to pave an entire road but would give some consideration to paving a portion of the road under special circumstances.

Commissioner King inquired about a dirt road off of Hwy 24 East that needs paving. Mr. Stone said he was familiar with the road, but has been unable to secure rights of way to pave the road.

Commissioner Baggett inquired as to how many miles of unpaved road are left in Cumberland County. Mr. Stone said approximately 30 miles. He projected all roads would be paved in Cumberland County by 2004.

In response to a question concerning whether or not the County could purchase rights of way in order to have a road paved, the County Attorney said counties do not have the authority to purchase rights of way, except for a county construction project. Unlike municipalities, counties are not in the "streets and highways" business.

Commissioner Warren noted that the NC DOT and the County does not determine paving priorities based on the color of one's skin, as suggested by Mr. Harris.

1. April 6, 2000, Guardian ad Litem Child Advocate Day in Cumberland County

PROCLAMATION

WHEREAS, the Guardian ad Litem/Court Appointed Special Advocate (GAL/ CASA) programs have established a distinguished record of public service through their work to enhance the quality of life for children; and

WHEREAS, all one hundred counties in North Carolina have a GAL program; and

WHEREAS, GAL volunteers come from a variety of professional, educational and ethnic backgrounds and act as advocates for abused and neglected children in the complicated and often unfamiliar court and child welfare systems; and

WHEREAS, the court appoints GAL advocates to serve as officers of the court, helping to improve the quality of information presented to the court by acting as the court's eyes and ears in the child's life; and

WHEREAS, April 2000 has been proclaimed Child Abuse Prevention Month an observance that reflects the purpose of GAL/CASA programs, which is to protect and defend children from harm and ensure that abused and neglected children are provided with the court-ordered services they need.

NOW, THEREFORE, the Board of Commissioners of Cumberland County hereby proclaims April 6, 2000 "Guardian ad Litem Child Advocate Day" in Cumberland County and urges all citizens to join in this observance.

(2) April 2000 "Alcohol Awareness Month" in Cumberland County.

ACTION: Approve

PROCLAMATION

WHEREAS, about 5.1 million Americans between 12-20 are "binge" drinkers (consuming 5 or more drinks in a row on a single occasion) including 2.3 million heavy drinkers (consuming 5 or more drinks at the same occasion on at least 5 different days); and

WHEREAS, approximately 9% of the nation's 8th graders, 22% of 10th graders and 33% of 12th graders have been drunk during the last month; and

WHEREAS, use of alcohol and other drugs is associated with the leading causes of death and injury (e.g.; motor vehicle crashes, homicides, and suicides) among teenagers and young adults; and

WHEREAS, people who begin drinking before age 15 are 4 times more likely to develop alcoholism than those who begin at 21; and

WHEREAS, alcohol use is implicated in one to two-thirds of sexual assault and acquaintance or "date" rape cases among teenagers and college students; and

WHEREAS, the total cost of alcohol use by youth - including traffic crashes, violent crime, burns, drowning, suicide attempts, fetal alcohol syndrome, alcohol poisonings and treatment - is more than \$58 billion per year.

NOW, THEREFORE the Cumberland County Board of Commissioners hereby proclaims April 2000 "Alcohol Awareness Month in Cumberland County" and calls upon all citizens, parents, governmental agencies, public and private institutions, businesses, hospitals and schools in Cumberland County to support efforts that will prevent underage drinking throughout our community, particularly those that recognize and encourage youth who are free of alcohol and other drugs.

(3) Dedication of the "Cumberland County Fallen Firefighters and EMS Memorial" and to honor and remember those who have lost their lives in the performance of their duty.

WHEREAS, the Cumberland County Board of Commissioners on the occasion of this dedication of the Fallen Firefighters and EMS Memorial, wishes to recognize and pay tribute to those volunteers and career emergency personnel that have given the ultimate sacrifice for the citizens of Cumberland County; and

WHEREAS, the members of the fire departments and EMS agencies of Cumberland County and the municipalities therein daily play a heroic role in protecting the life and property of its citizens; and

WHEREAS, it is important that all citizens understand the problems, duties, sacrifices and responsibilities of their fire and EMS personnel and agencies, and the members of those agencies recognize their duty to protect the life and property of the citizens they serve; and

WHEREAS, the citizens of Cumberland County recognize and appreciate the contributions made to them by the men and women of the fire and EMS community.

NOW THEREFORE, the Cumberland County Board of Commissioners recognizes

the dedication of this

CUMBERLAND COUNTY FALLEN FIREFIGHTERS AND EMS MEMORIAL

and urges the public to honor those fire and EMS personnel throughout Cumberland County and to remember those members of the fire and EMS community who lost their lives in the performance of duty.

(4) April 9-15, 2000, National County Government Week in Cumberland County

WHEREAS, as we enter the new millennium, it is important to review our past as we look to the future; and

WHEREAS, county governments began as a response to the needs of early settlers in our country, tracing their roots to the Anglo-Saxon local government 1,000 year ago. Counties first appeared in colonial America, making them older than the Republic itself; and

WHEREAS, as our country grew westward, so too did the number of counties. The primary functions of county government during the 1800s and 1900s involved judicial, road, law enforcement and other responsibilities in which the county acted mainly as an arm of the state; and

WHEREAS, over the last century, the responsibilities of county governments have grown enormously. County governments employ more than two million people and spend billions of dollars providing services to the people of the United States; and

WHEREAS, counties, today, are an important link within the nation's governmental structure with duties ranging from public safety to preserving the environment. They run housing and community development programs. They maintain parks, airports and transit systems. They work to solve area-wide problems, such as air pollution, solid waste disposal and drug trafficking. And, when the sick, the aged or the poor have nowhere else to go, it is the county that cares for them; and

WHEREAS, counties realize that volunteers play a vital role in providing services to citizens and saving tax dollars and appreciate the work that volunteers do; and

WHEREAS, county governments truly support the nation's citizenry, serving as their voice in town squares, state houses, Congress and the White House. Counties are providing solutions to meet many of the most challenging needs and ensuring a high quality of life for all. NOW, THEREFORE, the Cumberland County Board of Commissioners hereby proclaims the week of April 9-15, 2000 "National County Government Week in Cumberland County".

C. Approval of sole source procurement pursuant to NCGS 143-129 (f) for the upgrade to the Law Eenforcement Center and Sheriff's Office Annex security systems

The Sheriff's office proposes to undertake a project to upgrade BACKGROUND: the security systems for the Law Enforcement Center and the Sheriff's Office Annex. This project will be funded through a combination of a grant from the Governor's Crime Commission, local matching funds and drug forfeiture monies. The total cost is estimated to be \$153,000. The funding was previously approved by the Board of Commissioners. The Sheriff is requesting authorization pursuant to NCGS 143-129(f) Sole Source Procurement, to purchase the components for the system upgrade from the same vendor that provided the equipment for the existing security systems in the LEC and Annex. The hardware and software for the upgrade must be completely compatible with the existing system to assure a fully integrated, seamless security system. The statute provides that formal bidding requirements do not apply when one or more of three conditions exist, one of which is when "standardization or compatibility is the overriding consideration". In this case of this upgrade, compatibility is essential.

ACTION: Authorize the purchase of components from AFA Southeast, Incorporated, in the total amount of \$138,581.71 and waive the formal bidding requirements pursuant to NCGS 143-129(f) on the basis that standardization and compatibility are the overriding considerations.

D. Report on formal bid awards for \$100,000 or less approved by management.

BACKGROUND: The County Purchasing Policy delegates authority to the County Manager to award formal bids for purchases of \$100,000 or less. Bids were received for sports equipment for the County Recreation and Parks Department (Attachment A to these Minutes)

E. Sale of surplus county-owned real property acquired by tax foreclosure - 0.10 acre Reeves Land located in the Eastover Township BACKGROUND: The County acquired this land by tax foreclosure in 1994. The amount owed on the judgment plus interest and cost is \$518.34. The appraised tax value for this parcel is \$179.00. Mr. James Campbell made an initial bid to purchase this property for \$518.00; no upset bids have been received.

ACTION: Accept Mr. Campbell's bid in the amount of \$518.00 and upon receipt of the balance of the purchase price authorize the Chairman to execute a deed to James and Jacqueline Campbell.

F. Approval of Cape Fear Valley Health System subleases.

BACKGROUND: Cape Fear Valley Health System has submitted two subleases for consideration:

1. An amendment to the sublease with Medical Arts Family Practice, P. A. for unit 202 in the Medical Arts Building (101 Robeson Street). This amendment adds 430 additional square feet for a total leased space of 4,236 square feet. The rate for the additional space is \$15 per square foot, (the same rate as provided in the base lease). The effective date of the amendment is February 1, 2000.

2. An amendment to the sublease with Fayetteville Neurological Clinic, P.A. for unit 307 in the Medical Arts Building (101 Robeson Street). This amendment reduces the amount of space leased by 346 square feet from 1,264 square feet to 918 square feet. The rate remains at \$12 per square foot. The effective date of the amendment is March 1, 2000.

Dr. Franklin Clark, Chairman of the Downtown Steering Committee reviewed the report of his committee with the Board of Commissioners.

The Steering Committee retained a team of professional consultants with downtown experience to come to Fayetteville, meet with the community, assess the current situation and provide recommendations as to the best methods for advancing downtown development. The consultants provided the Committee with a SWOT Analysis (Strengths, Weaknesses, Opportunities, Threats) based on their research and interviews.

Strengths of the Community:

Present economic momentum Historic district Cultural facilities Marvin plan General understanding and interest in downtown development Willingness by governmental bodies to invest in downtown

Weaknesses related to downtown development included:

Lack of community consensus when defining downtown area Storefront vacancies Defeatist attitudes among a limited number of citizens Security and panhandlers Adjacent low wealth neighborhoods Railroad crossings Lack of long-term corporate leaders Presence of certain disruptive local civic leadership

Opportunities that exist for development include:

Ongoing catalytic projects such as the PWC building, Airborne Museum, AIT project and Convention & Visitors Center proposal for the old train depot;

Community conditions such as an engaged African-American community, recent property ownership changes, available infill land, engaged institutions of higher education, prominent places of worship, concern for parking management and active NC Division of Community Assistance regional office.

Threats to continued development include:

Inequitable suburban subsidy Fallout from previous organizations Undefined roles of area economic development groups

Based on the findings of the consultants, the Steering Committee agreed that **the focus of any downtown development initiative in Fayetteville should be primarily and consistently economic in nature.** Dr. Clark also noted that "downtown revitalization is a journey, not an event".

The Steering Committee makes the following recommendations to the Board of Commissioners for consideration:

1. Form a new economic development organization to promote economic development in downtown Fayetteville.

2. The new organization shall be structured as a private-public non-profit 501.c.6 organization.

3. Downtown is defined as follows: the Airborne Museum on the West, County Courthouse on the East, new County Jail on the South and Cross Creek on the North and add the Murchison Road corridor to the Fayetteville State University campus.

4. The budget will initially be funded by the public sector. However the level of funding is below the level enjoyed by the previous organization. The City of Fayetteville will be asked to contribute \$150,000 and the County of Cumberland will be asked to contribute \$48,000.

5. The new organization will require a staff of an executive director and one staff. As economic development occurs, staff expansion to a third person may be appropriate.

6. The office will be located in the new PWC building on Hay Street in downtown Fayetteville.

7. The new organization will need a responsible and dedicated group to guide and direct the efforts of economic development. There shall be 25 voting members on this Board of directors plus 11 ex-officio non-voting directors.

6. Consideration of amendments to the Fire Prevention Code Fee

Schedule

BACKGROUND: Ricky Strickland, Fire Marshal, recommends the Board approve the following amendments to the Fee Schedule:

1. Fees for fire protective signaling, detection or fire suppression system permits:

a. new installation, including plan review, approval, initial acceptance test and one reinspection - \$35.00
b. second & each additional reinspection acceptance test for new installations - \$35.00
c. fee for retrofits (alteration or addition) including plan review, approval, initial acceptance test and one reinspection - \$20.00
d. fee for second & each additional reinspection acceptance test for retrofits - \$20.00

2. Add civil citation for repeat violations of the Fire Prevention Code - 150% of the amount of the original citation.

3. Add fee for second & each additional reinspection for foster care homes, daycare homes, daycare centers, group homes, nursing homes and rest homes - \$35.00

4. Add fee for ABC Permit inspection - \$35.00

5. Delete fees for liquified natural gas and liquified petroleum gas inspections due to the transfer of responsibility to a state agency.

ACTION: Adopt amendments to the fee schedule as shown above.

Commissioner Warren cautioned that the County needs to keep in mind the effect these increases in fees have on businesses in our community. He said this is just another form of taxes. He said he was not in favor of putting on any additional fees for businesses to operate.

MOTION: Commissioner Warren moved to deny the request for amendments to the fee schedule.

SECOND: Chairman Melvin

DISCUSSION: In response to a question, the Fire Marshal indicated these fees are in line with what other counties are charging. He noted it takes an enormous amount of time and costs money to perform the inspections. In addition, some businesses that are not compliant require second visits. The Fire Marshal's office has three inspectors and one secretary. As the county grows there are more and more inspections to do. Commissioner King noted the Fire Marshal makes some argument for increasing the fees.

7. Consideration of an amendment to the Cumberland County Code, Section 10-48, Entrance at Minimum

BACKGROUND: This amendment will authorize the Manager to hire candidates for County employment up to the maximum of the salary ranged established for that position when there is a demonstrated inability to recruit at the minimum salary or if an applicant possesses exceptional qualifications or prior experience. The amendment requires the Manager to report any action hiring a candidate at more than 20% above the minimum range to the next meeting of the Personnel Committee.

ACTION: Adopt Resolution amending the Code.

RESOLUTION AMENDING CUMBERLAND COUNTY CODE SECTION 10-48

WHEREAS, the Board of Commissioners has previously adopted a Personnel Code for County employees which is codified as Chapter 10 of the Cumberland County Code; and

WHEREAS, the Board of Commissioners has been aware that the market for talented employees is and has been extremely competitive and that Cumberland County's ability to attract highly qualified individuals has been adversely affected; and

WHEREAS, the Board of Commissioners believes that it will be in the best interest of Cumberland County in attracting highly qualified individuals to amend Section 10-48 of the Cumberland County Code to afford the County Manager discretion in individual cases to respond to job market conditions, and that such an amendment would be preferable to a recurring series of ad hoc reviews and reclassifications of specific position classifications;

NOW, THEREFORE, BE IT RESOLVED by the Cumberland County Board of Commissioners that it amends Section 10-48(s) of the Cumberland County Code to read in its entirety as follows:

"When the county manager shall determine that there has been a demonstrated inability to recruit at the minimum salary, or if an applicant possesses exceptional qualifications or prior experience, the county manager may authorize the employment of the applicant at a salary level up to and including the maximum of the salary range provided for that position classification, subject to the availability of appropriated salary and benefit funds. The county manager shall report each action hiring an applicant at a salary level exceeding twenty percent (20%) above the minimum of the salary range for such classification to the next meeting of the Board of Commissioners' Personnel Committee."

MOTION: Commissioner Baggett moved to approve. SECOND: Commissioner King VOTE: UNANIMOUS

8. Consideration of transfer of Franchise Agreement and Ordinance

BACKGROUND: The Board of Commissioners approved a Franchise Ordinance and Franchise Agreement for Sessoms Properties, Inc., to provide food services at the new DSS building. Mr. Sessoms now advises he will be unable to fulfill the terms of the agreement due to family and personal reasons. He requests a transfer of the Ordinance and Agreement to Mr. Bob Biddix, who owns and operates the Dogwood Delis on Eastern Boulevard and Owen Drive. He has agreed to provide food services at the new DSS building pursuant to the terms of the Franchise Agreement. The County's Purchasing Agent advises that Mr. Biddix appears qualified to carry out the franchise.

ACTION: Approve the transfer to Mr. Biddix.

include transportation, raising money, etc. In addition, the Executive Committee will appoint some working committees to assist in preparation for the conference.
