1. PUBLIC HEARING

A. Public Hearing on the FY2003 Rural Operating Assistance Program (ROAP) Grant Application

BACKGROUND: The ROAP consolidates the Elderly and Disabled Transportation Program, Work First Transitional/Employment Transportation and the Rural General Public program into one application. The application includes \$117,262 in EDTAP funds, \$39,367 in Work First funds and \$58,339 in RGP funds for a total of \$214,968. EDTAP and Work First funds do not require a local match and are used to purchase transportation for Cumberland County residents meeting funding requirements. RGP funds can be used to finance up to 90% of the operating costs associated with general-public transportation with the remaining 10% to be derived from rider fares or local funds. RGP funds will be used to subsidize a feeder service in the Town of Spring Lake and the 10% local match will be generated through rider fares. A public hearing must be held prior to submitting the grant application.

Central Carolina Investments, Oakwood Mobile Home Park, Trease Drive and Charmain Street

BACKGROUND: On March 20, 2000, the Board of Commissioners adopted an Ordinance directing the demolition of 21 structures at Oakwood Mobile Home Park. Said work was accomplished and the Ordinance assessing property for the costs of demolition was adopted by the Board on July 2, 2001. Oakwood Mobile Home Park was split between two separate parcel identification numbers and the assessment of \$9,400 was inadvertently placed on each PIN number separately. This resulted in it appearing that the property owners were assessed \$18,000 instead of \$9,400.

ACTION: Amend Ordinances to reflect the correct lien in the amount of \$9,400.

C. Approval of sanitary sewer extension participation agreement between DTF, DAK, Wellman, City of Fayetteville PWC and County of Cumberland

BACKGROUND: Several industries located on Cedar Creek Road have received sanitary sewer service through contracts with the nearby Monsanto Wastewater Treatment Plant. With Monsanto's closing, the expiration of those contracts could jeopardize those industries' continued operations. An agreement has been drawn up between a DuPont joint venture (DuPont Teijin Films USA Limited Partnership, "DTF"), DAK Resins, LLC, Wellman, Inc., PWC through the City of Fayetteville and the County in which the parties would agree to fund an extension by PWC of a sewer line to serve Cedar Creek Business Center, a force main along Hwy. 53 and a lift station to serve those industries. The extension would run through Cedar Creek Business Center to serve Phase I. PWC would be the lead agency bidding out and overseeing construction of the project, which is estimated to be \$2.4 million. The parties are applying to Southeastern Economic Development Commission for a grant of \$1.2 million. The County has already earmarked \$730,000 to construct a sanitary sewer main to serve Phase I of Cedar Creek Business Center. DTK and DAK would fund half of the remaining \$470,000 balance or \$235,000, with DAK being responsible for \$61,100 (26% of that one-half) and DTF for \$173,900 (74% of that one half). The County and PWC would fund the other remaining half of the \$470,000 balance equally, not to exceed \$150,000 each.

ACTION: Approve the agreement and authorize the Chairman and Clerk to sign on behalf of the County, subject to such additions, revisions or deletions as may be acceptable to the County Manager and County Attorney.

- A. **Appointment of Chairman, First Vice Chairman & Second Vice Chairman for the Board of Equalization and Review**

BACKGROUND: The Board of Commissioners is responsible for appointing the Chairman, Vice Chairman and Second Vice Chairman for the Board of Equalization and Review. Currently George Turner is Chairman, William Holland is First Vice Chairman and Sherrill W. Jernigan is Second Vice Chairman. Mr. Turner will finish his second term on this Board on March 31; therefore a new Chairman needs to be appointed. The Interim Tax Administrator recommends that the Commissioners appoint the following:

5. Presentation by Dr. Tom McGinn, NC Department of Agriculture

Dr. McGinn told the Board about the importance of educating the public concerning foreign animal diseases such as Foot & Mouth Disease, Mad Cow Disease, the West Nile Virus, etc. Dr. McGinn noted these diseases are not in this county at this time, but could very well be introduced here by acts of terrorism or simply by someone from another country which does have the disease coming here and spreading it to our animal population. Dr. McGinn noted that the State Animal Response Team was formed in 1999 after Hurricane Floyd, during which over 3 million domestic and farm animals were lost. In addition there are 23 County Animal Response Teams who train on a regular basis to address animal emergencies. Cumberland County has a team with plans in place to address animal diseases and other animal-type disasters. Dr. McGinn said that the September 11 terrorism attack has changed our view of the world and our idea of homeland security. He said protecting the national and world food supply is critical. He urged that everyone be on alert for any suspicious activities around food stores, farms, etc. These animal diseases can wipe out our livestock population and destroy our food chain. He said that farmers and agribusiness have stepped up bio-security measures because of concerns about foreign animal diseases. Dr. McGinn noted that Cumberland County is particularly vulnerable to bio-terrorism because of Fort Bragg deployments out of country.

6. Presentation by Jeff Reitzel of the 2001 Manufactured Housing Task Force Report

The Task Force studied methods by which the County may increase the tax base and encourage development. Mr. Reitzel said that the 1999 Cumberland County Manufactured Housing Study and updates indicate the County's residential tax base continues to decline as well as assessed values per residential square foot. He said that generally, manufactured homes decrease in value while stick built homes increase.

Mr. Reitzel said the Task Force recommends that the Board of Commissioners consider the following recommendations:

- Explore listing/taxing all manufactured homes as real property for land and home under common ownership; (House Bill 253, approved as Session law 2001-506 is an act to provide that manufactured homes need not have multiple sections to qualify as real property for property tax purposes, to require the owner to surrender certificate of title when the manufactured homes becomes real property and to require an owner to file evidence of the

surrender of title with the register of deeds. The Bill also defines and clarifies the criteria for the Taxing Authority in determining the manufactured home's listing as personal property or real property. Exception – Group developments may need to be addressed as “home and land under common ownership”.)

- Address disparities between manufactured homes to stick built homes with regard to schedule of values & tax treatment/assessment (Tax Administration estimates that approximately 5,000 manufactured homes listed as personal property might qualify as real estate thus producing an increase in annual property tax revenue of approximately \$625,000);
- Address disparities between manufactured homes to stick built homes with regard to building permit fees (consideration should be given to a single fee based on square footage reflecting actual cost);
- Develop standards to enhance aesthetic value and structural appearance comparable to stick built homes;
- Encourage enforcement of minimum housing standards;
- Allow manufactured homes to be set up within the County only if HUD certified and taxes are current and continuously listed;
- Link tax moving permit to setup permit (put measures in place to coordinate the Inspections Department set up permit to the Tax Moving Permit administered by the Tax Office);
- Develop an incentive to implement development which increases the county's overall average assessed tax value;
- Support “one stop” permitting, improved communications, improved inspection scheduling and cross-training inspectors;
- Continue to work collectively to raise economic standards and thus affordability of stick-built housing by growing Cumberland County employment base and attracting higher paying sources of employment.

Mr. Reitzel noted that manufactured home developments can create an immediate impact on the county's obligation to provide infrastructure such as schools, fire & police protection, utilities, etc. Mr. Reitzel noted that the 1999 Cumberland County Manufactured Housing Study prepared by the Planning Department indicates that from 1994-99 manufactured home permits have continuously exceeded permits for stick-built homes resulting in a constant and continuing decline in assessed value per square foot for residential development.

The Task Force recommends that the Board direct the Cumberland County Joint Planning Board to propose ordinances, rules, restrictions and guidelines to allow the legal implementation of the Task Force recommendations, effective prior to the new revaluation year (January, 2003).

MOTION: Commissioner Council moved to direct the Joint Planning Board to propose ordinances, rules, restrictions and guidelines to allow the legal implementation of the Task Force recommendations, to be effective prior to the new revaluation year (January 2003).

Commissioner Henley suggested that staff could look at some of the recommendations immediately such as developing permitting fees, setting standards for refurbishing mobile homes, etc.

- **establish standards for refurbishing mobile homes;**
- **work on linking the tax moving permit to the setup permit;**
- **require all manufactured homes to be set up in our County to be HUD**

7. Presentation by Rick Heicksen of the proposed traffic options for Fort Bragg and Spring Lake

Rick Heicksen reviewed the proposed traffic solutions for Fort Bragg and Spring Lake, resulting from Ft. Bragg's heightened requirements for base security. This is not Fort Bragg's plan but a plan that was drawn up as a result of Fort Bragg's Protection Needs. Mr. Heicksen noted that there will be a meeting on April 16 in Raleigh to analyze the cost of the proposed plan as well as the impact on the area affected. At this point, nothing is final.

8. Presentation by Alex Lekas regarding Advanced Internet Technologies Economic Development Agreement with the County

Alex Lekas reported that AIT's Economic Development Agreement with the County is moving along fine after two years. He said their workforce is at 200 of a 250 commitment by the fifth year and climbing with salaries averaging \$33,500, of a commitment of \$35,000 by the fifth year and a capital investment to date of \$1 million of a commitment for \$2.5 million by the fifth year. He said AIT is nearing completion of a 20,000 square foot data center on the first floor of the Maiden Lane Headquarters. The data center is where the Metropolitan Area Network they've built in conjunction with the PWC ties in. They are also working on a partnership with the Cumberland County Library System. In addition, AIT is poised to launch a unified network, providing voice, video, and data services.

9. Consideration of referring Rezoning Case P02-08 back to the Planning Board for consideration of a conditional use overlay district and permit

BACKGROUND: The Board of Commissioners heard this case on March 18 and followed the recommendation of the Planning Board which was to deny the rezoning request. Although Mr. Espino, the petitioner, was at the meeting he did not sign up to speak on the case. There appeared to be some confusion about the process. Commissioner Warren is asking the Board to refer the case back to the Planning Board for consideration of a conditional use overlay district and permit.

ACTION: Refer back to the Planning Board for consideration of a conditional use overlay district and permit at no cost to the petitioner.

MOTION: Commissioner Baggett moved that this item be deferred to the next meeting so Commissioner Warren can be here, since he requested this item to be on the agenda.

10. Consideration of bid award for video visitation and signage at the Cumberland County Detention Center, pursuant to the emergency exception of General Statute 142-129(a)

BACKGROUND: On March 1, 2002, Miller Building Corporation of Wilmington, North Carolina, who has been the contractor responsible for the construction of the new Cumberland County Detention Center, notified us that it had abandoned our project. The responsibility for completion of the project has not been transferred by the Surety (American Home Assurance Company) who issued a performance bond for this project. Prior to Miller abandoning the project, Miller personnel had bid out the installation of the Video Visitation system and the signage package; however Miller did not actually execute the contracts with these subcontractors. The Surety is not prepared to issue contracts in their name, preferring to wait until a new Contractor is selected. The process could take several months. The lead time for the equipment acquisition and signage fabrication is from 7 to 15 weeks. The Surety has asked that the county move forward with contracting these items directly and issuing a change order deducting these amounts from the total contract price. Delay in acquiring these items will result in not being able to secure a certificate of occupancy nor will the facility be able to meet the requirement of the State's detention facility standards. It is anticipated by the Engineering Department that the project could be completed by July 1, 2002 deadline, if contracts for these items are issued quickly. The completion date also hinges upon the Surety getting a contractor in place quickly. Even if the Surety is not able to get a contractor

on board quickly, the work that remains to be completed is in Housing Unit C, which if necessary, can be isolated from the rest of the facility and contractors and equipment could enter from outside the building in that area without disrupting the operations of the rest of the facility.

The lowest responsive bidder to Miller Building for Video Visitation System was Telecom Engineering Consultants, Inc. of Florida in the amount of \$516,890. The lowest responsive bidder to Miller Building for the painted door numbering in the inmate areas was Mr. Jimmy Clark, Construction Services of Hope Mills in the amount of \$5,750. Engineering and the County Attorney recommend awarding these contracts on an emergency basis under GS 143-129 in order to ensure the greatest chance of meeting the July 1, 2002, opening date.

ACTION:

1. Authorize a contract with Telecom Engineering Consultants in the amount of \$540,000 which will include a 5% in-contract contingency.
2. Authorize a contract with ASI Signs in the amount of \$27,000 which includes a 5% in-contract contingency.
3. Authorize a contract with Jimmy Clark Construction Services in the amount of \$6,000 which includes a 5% in-contract contingency.
4. Provide that these authorizations are contingent upon the Surety confirming in writing that amounts the County spends under these contracts will be deducted from amounts owed under the Miller construction contract and/or to the Surety.
