C. Approval of the Report on Delinquent Taxes for Year 2002.

BACKGROUND: In accordance with NCGS 105-369, the Tax Administrator is reporting on the unpaid taxes for the current fiscal year that are liens on real property. The tax liens will be advertised by posting notice at the County Courthouse and by publishing each lien at least one time in one or more of the newspapers having general circulation in Cumberland County. The delinquent report is on display in the office of the Clerk to the Board.

ACTION: Accept the report and order the Tax Collector to advertise the liens in a newspaper of local circulation during April 2003.

D. Approval of Resolution to Allow the County to Participate in the Debt Setoff Collection Program.

BACKGROUND: NCGS 105A authorizes counties and cities to participate in a debt setoff program to submit any outstanding delinquent debt totaling \$50.00 or more though a local government clearinghouse to the NC Department of Revenue. The North Carolina Association of County Commissioners and the NC League of Municipalities initiated a joint Local Government Debt Setoff Clearinghouse program in 2002. Commencing January 20003 individual counties and cities may combine debts under a

single debtor's SSN to meet a \$50.00 minimum. Five Star Computing, Inc. of Columbia, South Carolina will administer the program. The Tax Administrator is interested in using this method of collection as one of the tools to increase the tax collection rate in Cumberland County. It also opens up opportunities for other county departments such as Solid Waste and the Public Library to more effectively collect delinquent debts. In addition, the County may collect on behalf of our municipalities.

ACTION: Adopt Resolution and enter into a Memorandum of Understanding and Rider, authorizing the County to participate in this collection program.

### **RESOLUTION**

WHEREAS, NCGS 105A, Setoff Debt Collection Act, authorizes the NC Department of Revenue to cooperate in identifying debtors who owe money to local governments and who qualify for refunds from the Department of Revenue; and

WHEREAS, the law authorizes the setting off of certain debts owed to local governments against tax refunds; and

WHEREAS, the NC Association of County Commissioners and the NC League of Municipalities have jointly established a clearinghouse to submit debts on behalf of Cumberland County, as provided by law.

NOW, THEREFORE, BE IT RESOLVED by the Cumberland County Board of Commissioners that the County will participate in the debt setoff program and hereby designates the Cumberland County Tax Administrator, or designee, as the person to hold hearings and conduct necessary proceedings on behalf of the County.

The Board Chairman is hereby authorized to execute such documents and agreements as necessary or desirable to participate in the debt setoff program.

E. Approval of Sole Source Purchases for Motorola 800 MHz Radios for the Sheriff's Department.

BACKGROUND: The Sheriff's Office has been leasing hand-held and vehicle 800MHz radios by Motorola for the last 4 ½ years. The Purchasing Department has confirmed that the purchase of 800MHz radios is within the guidelines to the Local Government Purchasing laws to permit sole source procurements when there are overriding issues of compatibility and standardization. This sole source falls within the guidelines to purchase the radios from Motorola and is much more cost-effective to the County taxpayers than to re-enter into a new lease agreement.

ACTION: Approve the sole source purchases for the Motorola 800 MHZ radios for the sheriff's Office.
