C. Approval of a Resolution Approving Tax Exempt Loan to Stoney Point Volunteer Fire Department for Purchase of Two Fire Trucks and Station Improvements.

ACTION: Adopt Resolution

RESOLUTION

WHEREAS, Stoney Point Volunteer Fire Department, Inc., has determined to finance an amount of up to \$1,000,000 for two fire apparatus, to replace a building roof, to add auxiliary power, add addition for an exercise room, add/install vinyl siding and to replace a septic system. The US Internal Revenue Code requires that for such financing to be carried out on a tax-exempt basis, this Board must first approve the financing. The County will not be liable for repayment of the debt. The Department held a public hearing on the financing after published notice, as required by the code. The Department has reported the proceedings of such hearing to this Board.

BE IT THEREFORE RESOLVED by the Board of Commissioners of Cumberland County, North Carolina, as follows:

"The County approves the Department's entering into the financing, as required under the Code for the financing to be carried out on a tax exempt basis. The County and the Department acknowledge that the Department will be solely responsible for repayment of such financing and that the County will have no obligation with respect thereto. The Department's conduct of the required public hearing is approved."

D. Approval of a Resolution Regarding the Loss of Textile and Furniture Jobs in North Carolina.

ACTION: Adopt Resolution

RESOLUTION

WHEREAS, since the implementation of NAFTA in the mid 1990's, there have been substantial losses of textile, apparel and furniture jobs in North Carolina; and

WHEREAS, the effects of the trade agreement have further hurt our domestic textile industry and continue to do so; and

WHEREAS, recent reports from our domestic textile industry suggest that China is poised to seize up to 75% of the remaining textile and apparel market once the remaining quotas are removed on January 1, 2005; and

WHEREAS, North Carolina has over one quarter of the total textile employment; and

WHEREAS, North Carolina has lost over 50,000 jobs in traditional textile, apparel and furniture industries since 2001.

NOW, THEREFORE, BE IT RESOLVED, that the Cumberland County Board of Commissioners urges the President of the United States and the U.S. Congress to do everything it can to combat widespread dumping of textile goods on U.S. markets, to address the failure of our trading partners to open their markets to our products, to take action to curb currency manipulation that threatens our textile and forest product industries, to initiate the "special China safeguard" on sensitive textile and apparel categories and to devote resources to fight illegal smuggling and customs fraud.

E. Approval of a Resolution Supporting a Statewide Initiative for Legislative and Funding Support for Enhanced and Improved Passenger Rail Service for the State of North Carolina.

ACTION: Adopt Resolution

RESOLUTION

WHEREAS, passenger rail service is an integral part of a comprehensive transportation system for the State of North Carolina; and

WHEREAS, economic development, tourism and job creation will benefit through the enhancement of a passenger rail system that serves the citizens of North Carolina and visitors to our state; and

WHEREAS, we applaud the State of North Carolina for development of comprehensive intercity rail services in urban jurisdictions throughout the state; and

WHEREAS, there is a vital need to provide a balanced transportation system both statewide and nationwide as demonstrated in the aftermath of the September 11, 2001 tragedies; and

WHEREAS, an increase in state funding for passenger rail service in North Carolina is necessary to support development of intercity rail services that can connect our small urban and rural areas of the state with the urbanized center of our state; and

WHEREAS, support by local and state elected officials is essential for the future of alternative transportation in North Carolina; and

WHEREAS, this resolution is a vehicle to express the unified support of communities and chambers of commerce throughout North Carolina for increased statewide funding for passenger rail service; and

WHEREAS, rail linkages between communities and regions within North Carolina establish and strengthen social, historical, commercial and cultural bonds; and

WHEREAS, the average return on investment for the surrounding community for station revitalizations throughout North Carolina is more than one dollar for every dollar invested; and

WHEREAS, the associated improvements to rail facilities will increase the efficiency and safety of rail service, help attract new freight traffic and provide environmental benefits by reducing the impact of truck traffic on North Carolina's highways and by reducing harmful emissions; and

WHEREAS, an integrated passenger rail system will enhance accessibility and reliability for key military locations and ports.

NOW, THEREFORE, BE IT RESOLVED, that Cumberland County, through the adoption of this resolution, fully supports the creation of a comprehensive passenger rail service to serve the State of North Carolina, with its ultimate objective to further economic opportunity, help preserve the environment, improve the quality of life and enhance public health, safety and welfare for all citizens, communities and regions.
