<u>Rezoning</u>

A. Case P04-21. The rezoning of an 11.0-acre portion of two tracts totaling 95.88 acres from R10 to R5A, or a more restrictive zoning district, on the south side of Spring Avenue, west of South Pine Tree Lane, owned by McCormick Farms.

The Planning Board recommends approval of R5A.

B. Case P04-22. The rezoning of 3.41 acres from A1 to RR, or a more restrictive zoning district, on the north side of Huckleberry Road, east of White Plains Drive, owned by James E. Blanchard, Sr.

The Planning Board recommends approval of RR.

#### Contested Cases

C. Case P04-06. The rezoning of 21.0 acres from A1 to R40, or a more restrictive zoning district, at the southwest quadrant of Butler Nursery and Marsh Roads, owned by Cumberland Group, LLC.

The Planning Board recommends denial of the rezoning request.

Speakers:

James McLean – representing the petitioners. Mr. McLean noted that, with the widening of Highway 87, access to the area is better. He said that R40 is best suited to control growth and would be appropriate for this area.

Hank Hutaff – buyer of this property. He said he did not believe an increase of 15 lots would affect the density in this area too much.

Celine Shoup – In favor of the rezoning. Concerned about development on Ramsey Street and the overcrowding of the schools there. She noted the schools in the Grays Creek area are better able to handle this subdivision.

Mark Seffels – Mr. Seffels, surveyor for the project, supports the rezoning. He said there is very little farm land in the area, mostly wooded and wet lands. He said it is ideally suited for homes.

James McRae, Jr. – Opposed to the rezoning. Many residents in the Grays Creek area oppose this rezoning. This is a rural area and they want to keep it that way. The company buying the property is from Wilmington. There is no water and sewer in the area. Concerned that if the property is rezoned, it will open the way for more requests for rezoning. Also, it will affect the schools; huts are currently being used at Grays Creek Elementary.

James MacRae, Sr. – Opposed to the rezoning. Residents don't want the land rezoned. Planning Board has said no to this twice. He asked the Board to honor the recommendation of the Planning Board.

James Cain – Opposed to the rezoning.

The Public Hearing was closed.

E. Case P04-24. The rezoning of 40.05-acre portion of a 65.36-acre tract from R5A/CUO, R6/CUO and C(P)/CUO to C(P), or a more restrictive zoning district, on the south side of Raeford Road, east of Cliffdale Road, submitted by John Gillis.

The Planning Board recommends approval of C(P).

F. Community Development 2004 Annual Action Plan.

Thanena Wilson, Director, Community Development reviewed the Plan with the Board. She noted that total funding for Program Year 2004-05 is \$2,771,492. Most of the funding will be used for housing activities.

B. Approval of Affirmative Marketing Policy and Fair Housing Marketing Plan.

BACKGROUND: Under the HOME Program, each participating jurisdiction must adopt affirmative marketing procedures and requirements for rental and homebuyer projects containing five or more HOME-assisted housing units. Affirmative marketing steps consist of actions to provide information and otherwise attract eligible persons in the targeted housing market to the available housing without regard to race, color, national origin, sex, religion, familial status or disability. In addition, the American Dream Downpayment Initiative, which is a new component of the HOME Program, has requirements for planned, targeted outreach for residents and tenants of public and manufactured housing, and for other families assisted by public housing agencies. These requirements have been included in the Affirmative Marketing Policy.

ACTION: Adopt the Plan

C. Approval of Revisions to Homebuyer Assistance Program Policy.

BACKGROUND: The American Dream Downpayment Initiative was signed into law on December 16, 2003. Funds made available under the ADDI statute have been allocated to participating jurisdictions to assist low-income families to become first-time homebuyers. Cumberland County received an allocation of \$84,099. Qualified applicants can receive up to \$5,000 for down payment and/or closing cost assistance. Community Development is also proposing the use of CDBG funds in the First-time Homebuyers Program.

ACTION: Approve the revisions to incorporate the use of CDBG and ADDI funds in the Homebuyer Assistance Program effective July 1, 2004.

D. Approval of Adoption of a Sliding Fee Scale for the Solid Waste Department Landfill Tipping Fees.

BACKGROUND: In March of this year, Bobby Howard, Solid Waste Director, requested the Finance Committee approve revising the Landfill Tipping Fee from \$37/ton to \$27/ton, in order to generate greater volume and thus reduce our declining revenues. The Finance Committee recommends a sliding fee scale be adopted as shown below, effective May 1, 2004:

Regular mulch is free; screened mulch is \$5 per cubic yard, double ground mulch is not currently produced.

NOTE: Proposed change involves screened mulch which would be priced @ \$5/cu.yd. or \$10/per pickup truck load and double ground would be priced the same as screened mulch.

NOTE: Price per ton will be based on customer's cumulative monthly tonnage of all waste classifications.

BACKGROUND: NCGS 143-129(f) provides guidance on situations in which formal bidding requirements are not applicable. Covered under this statute are situations in which standardization or compatibility is the overriding consideration. The Department of Social Services is in the process of upgrading its existing imaging system. It requests using its current vendor, DTI Integrated Business Solutions, for upgrade of its imaging system equipment.

Yarborough, Trustee, has offered to purchase the property for \$6,006.69 and has deposited \$600.67 in the Finance Office. The tax value of the property is \$5,810.00.
