BACKGROUND: NCGS 105-369 requires the Collector to report unpaid taxes for the current fiscal year that are liens on real property by the first Monday in February. The purpose of the report is to allow you to order the Collector to advertise the tax liens by posting notice at the County Courthouse and by publishing each lien at least one time in one or more of the newspapers having general circulation in Cumberland County.

Total Delinquent Taxes for Year 2003 as of 1/15/04: \$13,582,311 on 18,845 parcels or 11.29% of the Assessed Value

Total Delinquent Taxes for Year 2002 as of 1/22/03: \$11,987,246 on 17,741 parcels, or 11.44% of the Assessed Value

D. Approval of Declaration of Surplus County Property and Authorization to Accept Insurance Settlement.

BACKGROUND:

ACTION: Declare the vehicle surplus, authorize the Risk Manager to accept \$5,875 as settlement and allow St. Paul Insurance to take possession of the wrecked vehicle.

E. Approval of Engineering Agreement for Crown Complex Roofing and Wall Repair Projects.

BACKGROUND: In order to expedite this project, the Engineering Department solicited a proposal from Fleming & Associates for the wall repair and roof replacement projects. Fleming & Associates is a local structural engineering consulting firm that specializes in roof design work. The basis of compensation for services rendered is a lump sum amount of \$177,354 which includes all reimbursable expenses. The projected budget is \$1,970,600 of which \$1,175,497 is for construction of the roof replacement work, \$617,749 is for construction of the wall repair work and \$177,354 is for design and construction administration services. The construction budget for the wall repair work is inadequate to completely replace all the deteriorated mortar joints in the Crown Theatre and Crown Arena. As a result, critical areas will be identified to be repaired giving preference to the Crown Theatre. The balance of the repair work will be done in subsequent phases as funds are appropriated.

ACTION: Approve the Agreement with Fleming & Associates in the amount of \$177,354 and approve associated budget revision (B04-335).

F. Approval of Exception to the Conflict of Interest Rule for the Lease to Home Program.

BACKGROUND: Community Development received a request from The Women's Center of Fayetteville to allow an employee to purchase the property located at 5952 McDougal Drive, which was purchased under the Lease to Home Program. Mr. Ramon Rodriquez is the ESL and Command Spanish instructor in The Women's Center computer lab. He has no direct duties, responsibilities or decision-making authority related to the Lease to Home Program. Mr. Rodriquez' application will receive the same impartial and objective process used in all other such applications for these services.

BACKGROUND: The Board of Health, at its meeting on November 18, 2003, approved the implementation of a Restaurant Plans Review fee of \$200.00. RESOLUTION OF THE CUMBERLAND COUNTY BOARD OF COMMISSIONERS REQUESTING THAT ITS FEDERAL CONGRESSIONAL AND STATE GENERAL ASSEMBLY DELEGATIONS VIGOROUSLY PURSUE RELIEF FOR NORTH CAROLINA COUNTIES FROM OPEN-ENDED MEDICAID FUNDING BURDENS

WHEREAS, North Carolina counties administer Medicaid on behalf of the federal and state governments; and

WHEREAS, Medicaid is a means-tested program open to any potential recipient that meets the standards for eligibility; and

WHEREAS, Medicaid is a necessary component of the social safety net for disadvantaged persons in our society; and

WHEREAS, Medicaid has been the fastest growing area of county government spending in North Carolina over the last five years; and

WHEREAS, that expansion has occurred and continues To occur without regard to the economic or fiscal ability of a county to afford such rapid expanded cost; and

WHEREAS, the most recent session of the North Carolina General Assembly had before it various bills introduced to provide North Carolina counties relief from these historically rapidly increasing Medicaid costs; and

WHEREAS, such proposals generally contemplated phasing in such relief to North Carolina counties over several years; and

WHEREAS, like other North Carolina counties, Cumberland County has struggled to bear the burden of these historically rapidly rising Medicaid costs; and

WHEREAS, it is essential and critical to the fiscal health of North Carolina counties that such Medicaid relief be adopted.

NOW, THEREFORE, the Cumberland County Board of Commissioners urgently requests its federal Congressional delegation and its state General Assembly delegation to vigorously pursue revisions as soon as possible to the Medicaid funding provisions to provide North Carolina counties relieve from Medicaid costs.

K. Approval of a Resolution Requesting Full Federal Funding of the "No Child Left Behind" Act.

ACTION: Adopt Resolution

RESOLUTION OF THE CUMBERLAND COUNTY BOARF OF COMMISSIONERS REQUESTING THAT ITS FEDERAL CONGRESSIONAL PURSUE REVIEW OF UNREALISTIC FINANCIAL AID PENALKTIES UNDER THE "NO CHILD LEFT BEHIND" ACT WHILE AFFIRMING ACOUNTABILITY OF INDIVIDUAL SCHOOLS FOR THE SCHOLASTIC PROGRESS AND ACHIEVEMENT OF THEIR STUDENTS

WHEREAS, at the urging of the Bush administration, Congress passed the "No Child Left Behind" act; and

WHEREAS, that Act requires that individual schools across the nation in a short period of time meet stringent statistical measures and indices intended to reflect progress in the scholastic achievement of students in those schools of all backgrounds and walks of life; and

WHEREAS, the provisions of that Act will require the withholding of some federal education aid funding to schools that fall short of meeting those statistical measures and indices, and

WHEREAS, reputable estimates suggest that Congress' funding of the Act in the 2004 budget will leave North Carolina schools some \$500 million short of the amounts needed to implement the Act, in that the federal 2004 budget earmarks \$408.3 million for the Act in North Carolina, while the Congressional Research Services estimates that it will cost North Carolina \$907.4 million to full fund the Act's mandates; and

WHEREAS, IN North Carolina counties provide a significant portion of the revenues necessary to fund a free public education in the public schools, including to service and retire most of the debt issued to provide school buildings and other capital facilities for local school systems; and

WHEREAS, any shortfall in federal education aid to North Carolina schools necessary to implement will surely pressure North Carolina counties along with the State of North Carolina, to step in to make up for withheld federal funding.

NOW, THEREFORE, the Cumberland County Board of Commissioners urgently requests its federal Congressional delegation to vigorously seek full funding of the amounts necessary to implement the "No Child Left Behind" Act in North Carolina, or in the alternative pursue revision of the Act to eliminate unrealistic financial aid penalties through withholding of federal education aid to individual schools that have not yet met impractical statistical achievement targets within the time periods currently prescribed by that Act and, further,

The Cumberland County Board of Commissioners affirms that all students deserve a quality education, one that equips them to succeed in life and to be contributing citizens of our communities and of this great nation, and that schools must be and should remain accountable for the quality of education its students receive, and for the scholastic progress and achievement of those students, but not in a manner that risks harm to students most at need by depriving schools of necessary federal financial aid support.

The Cumberland County Board of Commissioners respectfully requests that Congress recognize that improving scholastic achievement for all students will require durable, steady progress over at least a five to ten year period, but inadequately funding federal education aid for the Act will harm the very students the Act is most intended to benefit by risking, if they fail to meet the Act's statistical benchmarks, withholding of essential and critical federal education aid resources necessary to promote their scholastic success, and, further, The Cumberland County Board of Commissioners respectfully requests that Congress recognize that any inadequate funding of, reduction in, or withholding of federal education aid is overwhelmingly likely to result in shirting that revenue obligation to states and, especially, local funding entities such as, in North Carolina, counties, and thus to become yet another unfunded federal mandate.
