- 1. **Public Hearing**
 - A. Public Hearing on Economic Development Incentive to LeBleu Corporation.

BACKGROUND: This public hearing is to consider a proposed Incentive Agreement with Le Bleu Corporation to locate a distribution and bottled water bottling facility in a 2.34 acre portion of Lot 6, Cumberland Industrial Center, Cumberland County, NC and to maintain employment of 8 to 10 full time jobs. The Company will commit to make an investment in ad valorem property tax valuation, over such valuation as of January 1, 2006, of \$790,000 by December 31, 2008. In return, the County would sell a 2.34 acre portion of Lot 6, Cumberland Industrial Center to the Company for \$40,000. The Company also has the potential to expand its facility, depending on market conditions, and add a five gallon bottled water bottling line within three years. If the Company expanded to add the additional bottling line, it would make an additional investment in ad valorem property tax valuation of approximately \$800,000. If the Company expands its facility and adds a five gallon bottled water bottling line by January 1, 1010, the County would make an economic development incentive payment of \$10,000 to the Company. The proposed incentive payment would be based on performance by Le Bleu of its commitment, and would also be conditioned on payment of ad valorem property taxes.

ACTION: Hold public hearing, determine if the proposed agreement is in the public interest and would promote the public health, safety and welfare, and consider whether to approve proposed Incentive Agreement with Le Bleu Corporation. If approved, approve the proposed Incentive Agreement with Le Bleu Corporation, with such revisions to the Incentive Agreement as may be acceptable to the County Manager and County Attorney, and authorize the Chairman to sign on behalf of the County.

The Chairman of the Board opened the Public Hearing.

Speakers: Phyllis Owens, Executive Vice President of the Cumberland County Business

Council, said this has been an ongoing project for over seven years. CCBC appreciates the County's efforts in getting the land developed to Le Bleu's

satisfaction.

B. Public Hearing on the FY 2006-2007 Annual Rural Operating Assistance Program (ROAP) Grant.

BACKGROUND: The NCDOT deadline for the yearly application for Rural Operating Assistance Program funds is May 12, 2006. This grant incorporates three parts of the Community Transportation Program: the Rural General Public allotment, Elderly and Disabled Transportation Assistance Program allotment, and the Work First allotment. The total award amount for the FY 06-07 ROAP Grant is \$260,546. The breakdown of funding is: Elderly and Disabled Transportation Assistance Program - \$106,199; Work First - \$48,836; Rural General Public - \$105,511. There is no local match required for the EDTAP or Work First funds. RGP funding is \$105,511. A local match of 10% of the fully allocated cost equals \$10,551, resulting in an overall total of \$116,062. RGP funds are currently being used for a bus route to Spring Lake, NC from the Cross Creek Mall. The Board of Alderman of the Town of Spring Lake has committed to provide the required local match if enough funding is not generated from the fares collected from passengers to cover the local match. The TAB is not requesting that Cumberland County provide any local match.

WHEREAS, Cumberland County recognizes the heroism of all law enforcement officers who have died in the line of duty – giving their lives to protect and serve the citizens of our country; and

WHEREAS, a permanent memorial has been designated and erected in memory of all those fallen officers and placed on the grounds of the Cumberland County Courthouse and the Sheriff's Office.

NOW, THEREFORE, the Cumberland County Board of Commissioners hereby proclaims May 7-13, 2006 as "CUMBERLAND COUNTY LAW ENFORCEMENT OFFICERS' WEEK" and May 10, 2006 as "PEACE OFFICERS MEMORIAL DAY." With this proclamation, the Board encourages all citizens of Cumberland County to recognize the contributions of those who serve their community in potentially dangerous circumstances and the ultimate sacrifice by those who have given their lives protecting and serving this county.

RESOLUTION SEEKING NORTH CAROLINA GENERAL ASSEMBLY FUNDING FOR THE SUPPORT OF THE FORT BRAGG/POPE AIR FORCE BASE REGIONAL LAND USE ADVISORY COMMISSION (RLUAC)

WHEREAS, the Fort Bragg/Pope Air Force Base Regional Land Use Advisory Commission (RLUAC) was organized in 1991 for the purpose of balancing the need to protect the military training areas from incompatible urban development, the Longleaf Pine Ecosystem from destruction, and the safety of the civilian population living near the bases;

WHEREAS, for nearly fifteen years RLUAC has been very successful in raising the public awareness of these important issues and encouraging sustainable land use practices;

WHEREAS, to become a permanent influence in the Fort Bragg region, RLUAC incorporated in September 2004 and achieved tax-exempt status as a 501(c)(3) corporation in February 2006;

WHEREAS, since RLUAC's membership is limited to Fort Bragg, Pope Air Force Base, seven counties and eleven municipalities, its opportunities to raise funding in support of its budget are very limited (local government dues only generate approximately \$11,000 annually);

WHEREAS, RLUAC's modest budget obligations cannot be met without an annual appropriation from the North Carolina State Budget;

WHEREAS, the County of Cumberland is a member of RLUAC and supports its mission, as stated in the adopted Bylaws;

WHEREAS, the County of Cumberland intends to continue financially supporting RLUAC with its own annual payment of membership dues.

THEREFORE, BE IT RESOLVED, that the County of Cumberland formally requests that the North Carolina General Assembly approve an annual and reoccurring appropriation of \$35,000 to support the RLUAC budget.
