Chairman Kenneth Edge thanked the Board members and staff for their support during his tenure as Chairman of the Board. He reflected on his year as Chairman, and on the history of our County. He noted the importance of the county government's role in the lives of our citizens. He recounted some of the accomplishments over the past year in county government:

- continued the funding agreement with the school system;
- concluded the year in excellent financial condition;
- developed a plan to provide additional schools/classrooms, a new library, and public health building;
- DSS recognized for winning a state-wide award for the outstanding County Program, "Reaching Out to Fight Hunger", awarded by the NCACC;
- inaugurated the "Cumberland County Cares" award for individuals/citizens/agencies doing good things in the county;
- initiated a county-wide discussion on government consolidation;
- partnered with community agencies in the inauguration of the Channel 5 Education Channel;

- celebrated Commissioner King's ascension to the Board of Directors of the National Association of Counties;
- recognized that two commissioners, Edge and Blackwell, were appointed to the Board of Directors of the NC Association of County Commissioners;
- celebrated the Town of Eastover becoming the ninth municipality within the County;
- approved plans for the courthouse plaza renovations and parking lot improvements at the Courthouse;
- agreed to contribute financially to the City of Fayetteville's Hope VI grant application;
- continued to effectively and efficiently employ a workforce of more than 2300 people in conducting county business;
- commissioners have spoken to people and groups throughout the community and mounted an intensive effort to acquaint the public with the facts about the recent sales tax proposal;
- opened a new state-of-the-art animal control facility and Sheriff's training center;
- continued and continues to support the American Heart Association, the United Way of Cumberland County and the Christmas food drive.

Chairman Edge noted he could best characterize Cumberland County today, as "challenges balanced with opportunity". He noted that "we face our own future knowing that nothing remains static; we here in Cumberland County must change, too, and continue the development and progress that has brought us to the 21st century." He also stated "it will take all of us – local leaders and citizens from every walk of life – working together to make the choices that will lead us to greatness or mire us in mediocrity." He challenged everyone to be on the team that aspires to greatness.

- ask each municipality if it would meet with the Board of Commissioners in joint session annually;
- meet with the school system at least twice a year to receive an update on improvements and future needs;
- staff would provide quarterly BRAC reports to the Board;
- encourage employees to participate in the Employee Incentive Program";
- continue the "Cumberland County Cares" initiative;
- meet with the leadership at Ft. Bragg and perhaps form a Civilian Military Council or become more active in the CCBC Military Affairs Council; and
- recognize excellence in job performance among our county employees.
