PUBLIC COMMENT PERIOD (6:45 PM – 7:00 PM)

County Manager Martin read the Public Comment Policy.

#### SPEAKERS:

Linda Lewis – Ms. Lewis stated that she has lived in Fayetteville for almost 47 years and has served 20 years on many local boards, with six of those years having served on the Animal Services Board. Currently, she is a member of the Fayetteville Animal Protection Society (FAPS). Ms. Lewis stated she has deep concerns for what has happened at Animal Services this past year. Ms. Lewis provided a handout which she prepared and requested the Board to read at a later time. She stated that the information provided shows the totally

incomprehensible situations which have prevailed at Animal Services. Ms. Lewis requested that a progressive move be made towards the twenty-first century.

Caroline Parsons – Ms. Parsons stated that she is a member of the FAPS board and is the past president. Ms. Parsons stated that she had talked to Dr. Kelly Ferris, Associate Professor of North Carolina State University College of Veterinarian Medicine, last week for almost an hour regarding the local shelter. She learned that someone in County administration had already contacted Dr. Ferris and appreciated the fact that this step had been taken by the County. Dr. Ferris stated to her that she has worked with many counties that have come to the crossroads that Cumberland finds itself at now. She hopes that the citizens, commissioners, county administration and other interested groups leave this meeting with a better understanding of what the hopes are for Animal Services and that all parties can work together to solve the problems of animal over population in Cumberland County. A suggestion was made to work with the Humane Society for a free assessment which would serve the FAPS request for an unbiased evaluation of the Animal Services shelter methods. A primary goal should be to address over population of animals.

Kathleen Howard – Ms. Howard stated she worked with Animal Services for a little over four years and was a shelter supervisor for three and a half years of that time. Ms. Howard questioned how the Animal Services Department paid for someone that was not in their department to go to the National Animal Control Association School when most of the department officers had not attended the school, especially when they were told that they were still in the process of interviewing for the Director position. Ms. Howard also questioned why there were not afforded for two workers from Animal Services to be on the interview board for the new Director after the Animal Services Department had been requested to nominate two co-workers to be on the interview board. Why wasn't the department afforded this opportunity in this selection process in the last few interviews?

Sarah O'Hanlon – Ms. O'Hanlon stated she was past president of FAPS and their organization has had dire concerns for animals in this transitory county. They have worked with Dr. Ferris many times about problems with shelter space. Ms. O'Hanlon feels that education is the key and provided the Board with the Mission Statement of Animal Services stating that no tangible results have been seen regarding the mission statement. The problems that she sees with the Animal Services department are neglected animals at the shelter, no education process, and no public awareness of problems regarding disease and pet over population. Ms. O'Hanlon suggested that pets be tracked via the rabies vaccination process in order to raise more revenue to be used for such things as education of the public on problems. She also feels better enforcement of animal cruelty laws are also needed. Inoculations at the time of entry into the shelter and timely public awareness of disease should be mandatory. The public should be made aware of the number of animals that are being euthanized each year.

Victoria Hawkins – Ms. Hawkins stated she is a responsible pet owner and that she has visited the shelter on many occasions. She stated that what happens to the animals in the shelter is horrifying and that the animals are being treated cruelly when Clorox is being used instead of hot water for cleaning the cages. She also expressed her opinion that there

was a more humane way to euthanize animals rather than the way it was done. Ms. Hawkins requested the board make a visit to the shelter to see for themselves the cruelty that is happening.

2. Presentation by John Lauby, DVM, CVCP, on Disease Control Matters regarding the County's Animal Shelter.

Dr. Lauby stated that he has lived in Cumberland County for 40 years and has been a veterinarian for 35 years and has been associated with Animal Services most of that time. Dr. Lauby provided information on canine distemper and explained how it is spread. He stated that there is an epidemic in North America at this time with this disease and everyone is working hard to prevent the spread of the disease. Dr. Lauby stated that a puppy can come into the animal shelter, can be isolated for three days, can be vaccinated and wormed, but can come down with the disease two weeks after it has been adopted. Animal Services departments are having to deal with the disease because people are not sufficiently vaccinating their animals. Dr. Lauby stated that 50% of canine distemper cases show no signs of it. He stated that with his help Animal Services is coming up with standard operating procedures, refining and revising policies, and educating staff. Dr. Lauby stated that at the request of County Manager James Martin, he is making more frequent visits to the shelter and improvements are being noticed. Dr. Ferris has offered her services and Dr. Stevens as a specialist from State will visit later to help go through all the procedures and evaluate them for improvements. Dr. Lauby stated that in the last six months, 3,000 adoptable animals have been taken in and 400 of those were adopted. For puppies of this group, it would mean vaccinations for about 200 puppies which the county would have to pay for since vaccinations have not been administered to them. He stated that he did not feel that taxpayers should have to shoulder this expenditure for individuals that abandon their pets. Dr. Lauby stated that Animal Services was formed to provide a barrier between the citizens of the County and the animals to protect them from rabies and not to provide a full veterinary service department.

Commissioner Gilfus requested Dr. Lauby to explain his relationship with Animal Services and he replied that he has been under a contract with them to provide the required medical license necessary for the department to be able to use controlled drugs and is on call for any medical situation that needs assessment or treatment. Commissioner Gilfus requested Dr. Lauby's professional opinion as to the need of hot water for maintaining a clean environment and Dr. Lauby stated that hot water does not kill bacteria or viruses except at extremely high temperatures and that is dangerous both to the animals and the workers. The items used kills almost 100% of bacteria and viruses and hot water is not needed for the cleaning process.

## 2A. Comments from Scottie Harris, Animal Services Director

Scottie Harris, Animal Services Director, stated that he did make mistakes in handling the canine distemper in the shelter, but did not knowingly allow animals to be adopted with distemper. He stated that he should have notified the public sooner about the possibility of their adopted pets having been exposed to the disease and that he is working diligently to correct the problems at the shelter. There were five cases of symptomatic distemper cases in November and December. Twenty-eight cases confirmed by a vet and seven symptomatic cases during January and February. Prevention measures increased in January and the public was informed on February 17<sup>th</sup>; and pet adoptions were halted on that date. Decontamination efforts were started in the shelter and in vehicles. Hot water is available in the building, but protocols do not call for hot water because it could cause harm to the animals as well as staff. Cleaning protocols are in line with the Department of Agriculture's requirements. Additional efforts include revising the intake procedures of animals and contracting with Dr. Lauby for additional hours and visits to the shelter. Contact has been made with other county shelters, other veterinarians and Dr. Kelly Ferris to see what they are doing to fight distemper. A comprehensive assessment of the shelter has been requested through the North Carolina State University College of Veterinarian Medicine. Additional improvements will be made based on their recommendation. Pet adoptions will resume March 16, 2010. Mr. Harris advised that more than 12,000 animals are placed in the shelter every year by Animal Services through drop offs or pickups. Animal Services was dispatched to 17,000 calls in the city and the county. Statistics show that the number of animals euthanized is around 80% and this percentage has been consistent since 2007. Rabies vaccinations clinics will be held throughout the county in April.

#### Comments from James Martin, County Manager

James Martin, County Manger, shared key actions being taken to improve the shelter's operation: recruiting of a shelter manager who has a vet tech background and experience will take place; providing additional training for the staff; recommending that a Commissioner liaison be appointed to the Animal Services Board; recommending establishing a non-profit Friends Organization like the public library model, which can help raise awareness and funds to be used for improvements and operations of the shelter that the county cannot fund; and a community outreach education coordinator position is being established which will help educate the community on responsible pet ownership. Mr. Martin stated that Mr. Harris and County management are committed to making the county's Animal Services Department one of the best in North Carolina.

# Additional comments from County Commissioners and Staff:

Commissioner Keefe stated that the current way of handling licensing fees does not encompass all pet owners and hoped that the Board would consider another mechanism of collecting fees from all resident who own pets. Commissioner Gilfus questioned Mr. Harris as to his understanding of the purpose of Animal Services. Mr. Harris responded that it protects the public from rabid animals and is not designed to be a long-term facility. The facility design was for a fifteen year growth and to hold animals for five days. Currently, animals are held for three days and some are held for ten days.

Commissioner Edge questioned whether periodic inspections were performed by the Department of Agriculture and Mr. Harris stated that they are required to inspect annually. The shelter has received only one notice of violation in the past year and this was for not maintaining certain paperwork unrelated to shelter operations and this deficiency was corrected within two weeks and the shelter was re-inspected with no violations. Commissioner Edge asked for information on what the Board has approved regarding staffing. Mrs. Cannon, Assistant County Manager, advised that the new facility opened in the fall of 2007 and since the budget year of 2006, the County has increased the budget \$670,000 and added ten positions: one was a custodian, four support staff in the intake area, four shelter attendants, and one deputy director. Education and responsible pet ownership is the best way to curb the influx of animals into the shelter.

Rick Moorefield, County Attorney, verified that the Animal Services department was created by an ordinance put in place by the Board to address the County's responsibilities. The Animal Services department is one of the few County departments that is set up by an ordinance and enacted by the Board. There are basically two things that counties are required by law to provide: rabies control, which is under the jurisdiction of the Public Health Director, and a hearing panel established by the Board to consider potentially dangerous dog cases. Not only does the Animal Services Board serve as the panel for potentially dangerous dogs, they also serve in an advisory capacity to the Animal Services department and to the Board of Commissioners, they also serve as an appeals board for certain functions of the Animal Services department, and they are also responsible for providing an educational program on animal issues. The Animal Services department enforces state laws and county ordinances that relate to animal welfare, administers the animal control programs of those municipalities that contract by interlocal agreement with the County and operate the shelter. There is actually a Sheriff's Deputy that works in Animal Services to investigate and enforce state criminal actions. Mr. Moorefield stated the shelter operations and euthanasia procedures are fully regulated by the Department of Agriculture with very stringent and detailed controls. Mr. Moorefield concluded his comments stating that the County has gone beyond the State minimum requirements with regards to animal services and Cumberland County's Animal Services department is doing a great job with the limited resources they have available to them.

Commissioner King reminded members that a spay and neuter program has been discussed in the past and Mr. Martin advised any animal that is adopted from the shelter must go to a veterinarian for spay and neutering before adoptive parents can take possession of the animal.

Mr. Martin stated that he would like to rebut a comment by one of the public comment speakers who raised the question about the County paying for an individual that was applying for the Director's position to go to school. Mr. Martin stated he believes that the comment was in error and believes a candidate for that position may have paid their own way, because he feels certain he would have known if the County paid for this school.

BACKGROUND: On March 1, 2010, the Board approved the minutes from the earlier Board of Commissioners' regular/rezoning meeting for February 16, 2010. However, under Item 3, the minutes read incorrectly for Item 3.B – Case No. 10-03 and Item 3.D – Case No. 10-05 (see attached). The minutes should read as follows:

- Item 3.B The Planning Board recommends approval of the request for rezoning to C2(P) Planned Service and Retail District.
- Item 3.D The Planning Board recommends approval of the request for rezoning to C(P) Planned Commercial/Conditional Use District to shift the commercial zoning line and approval of the Permit, provided that all previous conditions, which the property owner has verbally agreed, are adhered to.

ACTION: Approve the corrections to the February 16, 2010 Board of Commissioners' Regular/Rezoning Minutes.

C. Approval of a Resolution of Intent to Accept an Offer to Purchase Certain Equipment Pursuant to NCGS 160A-269.

BACKGROUND: Cumberland County has two Mosley 200 HP horizontal balers that have not been used for over ten years. There has been some interest and a proposal made by Quality Recycling for the balers. It will cost the County approximately \$50,000 to remove these balers. Quality Recycling has offered us \$50,000 for the first baler and \$40,000 for the second baler and they would pay for the removal.

Whereas, the Board of Commissioners has determined to dispose of the equipment described herein in accordance with the negotiated offer, advertisement and upset bid method of sale.

Be it hereby resolved that the Board of Commissioners proposes to accept the offer of Quality Recycling Equipment, Inc., to purchase 2 used Mosley Bulldog balers and conveyer systems installed at the Cumberland County Solid Waste Facility for a total price of \$90,000, with purchaser to pay all cost of dismantling and removing.

The Clerk is directed to advertise the Board's intent to accept this offer subject to the upset bid procedure of N.C.G.S. § 160A-269 and to report when the last qualified bid is received at the next board meeting occurring thereafter.

BACKGROUND: The Cumberland County Sheriff's Office would like the Board of Commissioners to declare a 2001 Ford Crown Victoria (VIN No.: 2FAFP71W41X125464) Fleet 342 as surplus and authorize that the vehicle be donated to the Fayetteville/Cumberland County Crime Stoppers.

Commissioner Keefe questioned whether the water districts in that area will be available for growth and Mr. Denning advised that as each town expands, they will extend their systems and that is why one of the recommendations is for them to revisit their water policy for extending that service. He stated that water systems from Harnett County, the City of Dunn, Wade and the Eastover Sanitary District (ESD) are recommended to be allowed to be extended to the Area. All of these systems have an adequate public supply except Wade, whose source is wells. Commissioner Keefe just wanted to confirm that this plan is consistent with the Commissioners' plan for extending good drinking water to the entire county.

# COMMUNITY TRANSPORTATION PROGRAM RESOLUTION Section 5311 FY 2011 RESOLUTION

WHEREAS, Article 2B of Chapter 136 of the North Carolina General Statutes and the Governor of North Carolina have designated the North Carolina Department of Transportation (NCDOT) as the agency responsible for administering federal and state public transportation funds; and

WHEREAS, the North Carolina Department of Transportation will apply for a grant from the US Department of Transportation, Federal Transit Administration and receives funds from the North Carolina General Assembly to provide assistance for rural public transportation projects; and

WHEREAS, the purpose of these transportation funds is to provide grant monies to local agencies for the provision of rural public transportation services consistent with the policy requirements for planning, community and agency involvement, service design, service alternatives, training and conference participation, reporting and other requirements (drug and alcohol testing policy and program, disadvantages business enterprise program, and fully allocated costs analysis); and

WHEREAS, the County of Cumberland hereby assures and certifies that it will comply with the federal and state statutes, regulations, executive orders, Section 5333 (b) Warranty, and all administrative requirements related to the applications made to and grants received from the Federal Transit Administration, as well as the provisions of Section 1001 of Title 18, U.S.C.

NOW, THEREFORE, be it resolved that the County Manager of the County of Cumberland is hereby authorized to submit a grant application for federal and state funding, provide the required local match, make the necessary assurances and certifications and be empowered to enter into an agreement, with the NCDOT to provide rural public transportation services.

# RESOLUTION CLOSING OF A PORTION OF AN UNNAMED STREET NORTH OF DEDICATION DRIVE

WHEREAS, a petition has been submitted to the Cumberland County Board of Commissioners (the "Board") by an adjoining landowner to close a portion of a forty foot unnamed street located on the northern side of Dedication drive and the western side of Gillespie Street in Pearces Mill Township, in Cumberland County;

WHEREAS, following proper notice, the Board held a public hearing on the question of the closing of such street on the 15<sup>th</sup> day of March, 2010, and heard all interested persons who appeared with respect to whether the closing would be detrimental to the public interest or to any individual's property rights; and

WHEREAS, following the public hearing the said Board found and determined that such public street is not under the control of the North Carolina Department of Transportation; that no person would be deprived of reasonable means of ingress and egress to his property by such closing, but that the reservation of certain easements would be appropriate and desirable; and that it is therefore not contrary to the public interest to close such street, subject to the reservation of the easements described below;

NOW THEREFORE, the Cumberland County Board of Commissioners hereby RESOLVES, pursuant to authority granted by G.S. 153A-241, that the public street more particularly described below be, and it is hereby, closed, subject, however to the continued dedication and preservation of an easement therein for existing and future utilities, and of an easement therein for public safety emergency vehicle access:

Being that portion of the unnamed street 40 feet in width as shown on the plat filed in Book 9 at page 39 in the Cumberland County Registry from its southern-most terminus in the street identified as NC State Road No. 1344 on the plat filed in Book 34 at page 53 (now named Dedication Drive) to its intersection with the line running from the north-eastern corner of Lot 39 and the north-western corner of Lot 12 as shown on the plat filed in Book 9 at page 39.

And the Board further RESOLVES, that a certified copy of this Resolution be recorded in the Cumberland County Registry.

Adopted this 15<sup>th</sup> day of March, 2010.

RECOMMENDED/PROPOSED ACTION: If the Board of Commissioners makes the required statutory finding and decides to close this portion of the forty foot unnamed street, that the Board adopt the attached resolution and direct the staff to record it in the Cumberland County Registry.
