Chairman Keefe called the meeting to order.

INVOCATION AND PLEDGE OF ALLEGIANCE – Commissioner Melvin recognized Larry Bragg, Elder at Faith Community Church, who provided the invocation followed by the Pledge of Allegiance to the American Flag.

Introduction of Assistant County Manager: Quentin T. McPhatter

James Martin, County Manager, introduced Quentin T. McPhatter as the county's assistant county manager for auxiliary services. Mr. Martin provided a brief bio of Mr. McPhatter's past work experience, education and professional associations. Mr. Martin stated Mr. McPhatter will join the county's management team on January 13, 2014.

As outgoing chairman, Commissioner Keefe thanked the Board of Commissioners for their support during the last year and for the insight and experience they brought to the table. Commissioner Keefe also thanked county administrative staff for being flexible and for focusing on decisions that are in the best interest of the county. Commissioner Keefe thanked staff of the Public Information Office for their work with the Citizens' Academy and Cumberland Matters and for keeping the public informed. Commissioner Keefe also thanked the county attorney for his "can do" attitude with negotiations which served the best interests of the county. Commissioner Keefe thanked the clerk's office for their support. Commissioner Keefe provided a synopsis of accomplishments over the past year to include a new Veterans Services office and director, the hiring of a Finance Officer, a countywide animal control ordinance and increased animal adoption rates, Library System national accreditation and service awards, the Sheriff's Office and Public Health Department's state accreditation, restructured employee classification

system, initiation of nonsmoking campuses on county facilities, sales tax distribution agreement with the nine municipalities, mental health merger to a state accredited managed care organization, working with Cape Fear Valley Health System to become a crisis intervention services drop-off point, the detention center expansion, private management of the Crown Coliseum, and the leadership training and customer service programs for county employees in order to serve citizens with professionalism, respect, integrity with accountability, diversity and excellent customer service (PRIDE).

2. Presentation of Plaque to Outgoing Chairman

On behalf of the Board of Commissioners, Commissioner Council presented a plaque to outgoing Chairman Keefe in appreciation of his leadership as Chairman of the Cumberland County Board of Commissioners.

As the incoming Chair, Commissioner Council recognized county department heads, family members and colleagues in attendance. Commissioner Council also recognized Mayor Chris Rey of Spring Lake and Fayetteville City Council Member Katy-Ann Davy, Cumberland County Register of Deeds Lee Warren, Cumberland County Sheriff Earl "Moose" Butler and Fayetteville State University Vice Chancellor for Institutional Development Getchel L. Caldwell.

Commissioner Council offered remarks and stated she will represent the majority of the Board of Commissioners on all issues. Commissioner Council stated the Board of Commissioners cannot always choose its projects because the State often mandates where county funds should go. Commissioner Council stated while the county has been busy building a detention center expansion, it also has to dedicate funds for schools. Commissioner Council stated the retention of county employees and escalating health care costs are other hurdles the Board of Commissioners has to face in addition to recurring costs associated with the provision of citizen services through the Cumberland County Library, the Department of Social Services, Public

Health Department and Child Support Services. Commissioner Council thanked the Board of Commissioners for electing her as Chair.
